SENATE SUBSTITUTE FOR HOUSE BILL NO. 5178

A bill to amend 1974 PA 258, entitled "Mental health code,"

(MCL 330.1001 to 330.2106) by adding section 206b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 206b. (1) The department shall do all of the following:
- 2 (a) Establish, maintain, and revise, as necessary, a uniform
- 3 community mental health services credentialing program for state
- 4 department or agency use as required in this section. The state
- 5 department's or agency's credentialing and recredentialing process
- 6 must be compliant with national standards. The department may
- 7 consult with other state departments and agencies that are required
- 8 to comply with the program established under this section.
 - (b) Ensure that the uniform credentialing program does all of

- 2 (i) Creates uniformity in this state to streamline providing
 3 community mental health services by state departments and agencies
 4 and to enhance workforce development, training education, and
 5 service delivery.
 - (ii) Eliminates hardship surrounding the functioning and operating of community mental health services provided by state departments and agencies to residents of this state.
- 9 (iii) Establishes a uniform credentialing requirement for 10 individuals who provide community mental health services through a 11 state department or agency, by requiring providers of community 12 mental health services to establish, maintain, revise, and make 13 available, as necessary, a profile as maintained by the department 14 that contains information necessary for the community mental health 15 services credentialing process, which must adhere to national 16 standards from accrediting bodies such as the Joint Commission, 17 Commission on Accreditation of Rehabilitation Facilities, Council 18 on Accreditation, National Committee for Quality Assurance, or 19 other credible body as approved by the department.
 - (iv) Promotes policies that support adequate staffing and evidence-based skills or training to meet the needs of the residents of this state and the state departments and agencies that provide community mental health services.
- (ν) Complies with the national certification standards for
 community mental health counselors and professionals.
- (vi) Meets the needs of the populations served by each state department or agency that provides, either directly or through a contract, community mental health services to residents of this state.

- (c) By 6 months after the effective date of the amendatory act that added this section and annually after that date, submit a report to the legislature that describes its activities under this section, including the establishment of and any revisions to the uniform credentialing program.
- 6 (2) A state department or agency that provides, either 7 directly or through a contract, community mental health services to 8 residents of this state must comply with the uniform credentialing 9 program and utilize the provider information profile maintained by 10 the department as provided in subsection (1). On and after the date 11 the uniform credentialing program is certified by the director of the department as in full force and effect, the state department or 12 13 agency subject to this subsection must ensure that all of the 14 forms, processes, and contracts it uses that relate to providing 15 community mental health services comply with the uniform 16 credentialing program. This section does not apply to health plans 17 under contract with this state to provide services under the 18 Medicaid program or health plans or insurers regulated by the 19 insurance code of 1956, 1956 PA 218, MCL 500.100 to 500.8302. 20 Health plans under contract with this state to provide services 21 under the Medicaid program or health plans regulated by the 22 insurance code of 1956, 1956 PA 218, MCL 500.100 to 500.8302, may 23 use plan-specific processes and are not required to use the uniform 24 community mental health services credentialing process established 25 by the department.
 - (3) The credentialing and recredentialing process must be conducted and documented for at least the following health care professionals:
 - (a) Physicians.

- 20 333.17601.
- 21 (4) The department may establish policy and promulgate rules
- 22 to implement this section according to the administrative
- 23 procedures act of 1969, 1969 PA 306, MCL 24.201 to 24.328.
- 24 (5) As used in this section:
- 25 (a) "Community mental health services" means services provided
- 26 under a community mental health services program, including mental
- 27 health treatment and substance use disorder treatment.
- 28 (b) "Uniform credentialing program" or "program" means the
- 29 uniform community mental health services credentialing program

- 1 established, maintained, and revised as required in subsection
- 2 (1)(a) and includes recredentialing.
