- 7 or services, or both, manufactured or provided by Michigan
- 8 businesses, if they are competitively priced and of comparable

- 25 (b) Fiscal year-to-date expenditures by appropriation unit.
- (c) Fiscal year-to-date payments to a selected vendor,
- 27 including the vendor name, payment date, payment amount, and

- 1 payment description.
- 2 (d) The number of active department employees by job
- 3 classification.
- 4 (e) Job specifications and wage rates.
- 5 Sec. 212. Within 14 days after the release of the executive
- 6 budget recommendation, the department shall cooperate with the
- 7 state budget office to provide the senate and house appropriations
- 8 chairs, the senate and house appropriations subcommittees chairs,
- 9 and the senate and house fiscal agencies with an annual report on
- 10 estimated state restricted fund balances, state restricted fund
- 11 projected revenues, and state restricted fund expenditures for the
- 12 fiscal years ending September 30, 2019 and September 30, 2020.

- 14 accessible website, a department scorecard that identifies, tracks,

- 24 against an employee for communicating with a member of the

- 26 Sec. 216. The department shall provide biannual reports to the
- 27 subcommittees, the senate and house fiscal agencies, and the state

- 1 budget office, which shall provide the following data:
- 2 (a) A list of all major work projects, including a status
- 3 report of each project.
- 4 (b) The department's financial status, featuring a report of
- 5 budgeted versus actual expenditures by part 1 line item including a
- 6 year-end projection of budget requirements. If projected department
- 7 budget requirements exceed the allocated budget, the report shall

- Sec. 217. The appropriations in part 1 are for the core
- 17 services, support services, and work projects of the department,
- 18 including, but not limited to, the following core services:
- 19 (a) Armories and joint force readiness.
- 20 (b) National Guard training facilities and air bases.
- 21 (c) Michigan youth challenGe academy.
- (d) Military family relief fund.
- (e) Starbase grant.
- 24 (f) National Guard tuition assistance program.
- 25 (g) Michigan veterans affairs agency administration.
- 26 (h) Veterans service grants.
- 27 (i) Veterans' trust fund administration.

- 1 (j) Veterans' trust fund grants.

- 22 duties of an existing unclassified employee position, the
- 23 department shall notify the subcommittees and the senate and house

- 25 Sec. 302. (1) From the funds appropriated in part 1 for
- 26 military operations, effective and efficient executive direction

- 1 and administrative leadership shall be provided to the department.
- 2 (2) The department shall operate and maintain National Guard

- 4 (3) The department shall evaluate armories and submit a report
- 5 as provided under section 216 of this part on the status of the

- 10 shall work to provide a culture that is free of sexual assault,

- 6 prioritized project list to correct the most critical facility
- 7 shortfalls across the inventory of armories in this state.
- 8 Sec. 303. (1) The department shall maintain the Michigan youth
- 9 challeNGe academy to provide values, skills, education, and self-
- 10 discipline instruction for at-risk youth as provided under 32 USC
- **11** 509.
- 12 (2) The department shall take steps to recruit candidates to
- 13 the challenGe academy from economically disadvantaged areas,
- 14 including those with low-income and high-unemployment backgrounds.
- 15 (3) The department shall partner with the department of health
- 16 and human services to identify youth who may be eligible for the
- 17 challeNGe academy from those youth served by department of health
- 18 and human services programs. These eligible youth shall be given
- 19 priority for enrollment in the academy.
- 20 (4) The department shall maintain the staffing and resources
- 21 necessary to train and graduate at least 114 students per cohort
- **22** (228 annually).
- 23 (5) The department shall ensure individual academic success as
- 24 measured by the number of individuals who have received a general
- 25 equivalency diploma, high school diploma, or high school credit
- 26 recovery or by the improvement of tests of adult basic education
- 27 scores, or both.

- 1 (6) Any unexpended private donations to support the Michigan
- 2 youth challeNGe academy at the close of this fiscal year shall not
- 3 lapse to the general fund but shall be carried forward to the
- 4 subsequent fiscal year.
- 5 Sec. 304. (1) The department shall provide grants for
- 6 disbursement from the military family relief fund, as provided
- 7 under the military family relief fund act, 2004 PA 363, MCL 35.1211
- 8 to 35.1216, and R 200.5 to R 200.95 of the Michigan Administrative
- 9 Code.
- 10 (2) The department shall provide information on the revenues,
- 11 expenditures for advertising and assistance grants, and fund
- 12 balance of the Michigan military family relief fund, as provided
- 13 under section 216 of this part.
- 14 (3) The department shall provide sufficient staffing and other
- 15 resources to provide outreach to the Michigan families of members
- 16 of the reserve component of the Armed Forces of the United States
- 17 called into active duty and to support the processing and approval
- 18 of grant applications for this fiscal year under the Michigan
- 19 military relief fund and report those applications as provided
- 20 under section 216 of this part.
- 21 Sec. 305. (1) The department shall provide Army and Air
- 22 National Guard forces, when directed, for state and local
- 23 emergencies and in support of national military requirements.
- 24 (2) The department shall operate and maintain Army National
- 25 Guard training facilities, including Fort Custer and Camp Grayling.
- 26 (3) The department shall maintain a system that measures the
- 27 condition and adequacy of air facilities using both quality and

- 1 functionality criteria.
- 2 (4) The department shall operate and maintain Air National
- 3 Guard air bases, including Selfridge Air National Guard base,
- 4 Battle Creek Air National Guard base, and Alpena combat readiness
- 5 training center.
- **6** (5) The department shall provide the following information as
- 7 provided under section 216 of this part:
- 8 (a) The apportioned and assigned strength of the Michigan Army
- 9 National Guard.
- 10 (b) The apportioned and assigned strength of the Michigan Air
- 11 National Guard.
- 12 (c) Recruiting, retention, and attrition data, including
- 13 measurement against stated performance goals, for the Michigan Army
- 14 National Guard.
- 15 (d) Recruiting, retention, and attrition data, including
- 16 measurement against stated performance goals, for the Michigan Air
- 17 National Guard.
- 18 Sec. 306. There is created and established under the
- 19 jurisdiction and control of the department a revolving account to
- 20 be known as the billeting fund account. All of the fees and other
- 21 revenues generated from the operation of the chargeable transient
- 22 quarters program shall be deposited in the billeting fund account.
- 23 Appropriations will be made from the account for the support of
- 24 program operations and the maintenance and operations of the
- 25 chargeable transient quarters program and will not exceed the
- 26 estimated revenues for the fiscal year in which they are made,
- 27 together with unexpended balances from prior years. The department

- 1 shall submit an annual report of operations and expenditures
- 2 regarding the billeting fund account to the appropriations
- 3 committees of the senate and house of representatives, the senate
- 4 and house fiscal agencies, and the state budget office at the end
- 5 of the fiscal year.
- 6 Sec. 307. (1) The department shall maintain a National Guard
- 7 tuition assistance program for members of the Michigan Army and Air
- 8 National Guard.
- 9 (2) The objective of the National Guard tuition assistance
- 10 program is to bolster military readiness by increasing recruitment
- 11 and retention of Michigan Army and Air National Guard service
- 12 members, to fill federally authorized strength levels for the
- 13 state, to improve the Michigan Army and Air National Guard's
- 14 competitive draw from other military enlistment options in the
- 15 state, to enhance the ability of the Michigan Army and Air National
- 16 Guard to compete for members and federal dollars with surrounding
- 17 states, and to increase the pool of eligible candidates within the
- 18 Michigan Army and Air National Guard to become commissioned
- 19 officers.
- 20 (3) The department shall make efforts to increase the number

- 25 graduation rate in Michigan, whichever is higher. To evaluate the
- 26 effectiveness of the program, the department shall monitor the
- 27 number of new recruits and new reenlistments and the percentage of

- 1 those who become participants in the program to determine whether
- 2 the percentage of authorized Michigan Army and Air National Guard
- 3 strength obtained and retained is competitive in comparison with
- 4 the neighboring army and air national guards from Illinois,
- 5 Indiana, Ohio, and Wisconsin.
- 6 (4) Not later than March 1, 2020, the department shall provide
- 7 a report to the subcommittees on the Michigan National Guard
- 8 tuition assistance program. The report shall include the number of
- 9 guard members receiving tuition assistance, where those guard
- 10 members received education or training under the program, the
- 11 average amount of financial assistance received, the total funds
- 12 spent on the program, and, in the opinion of the department, after
- 13 those expenditures, whether any unmet needs remained. The report
- 14 shall also include performance data regarding the number of members
- 15 denied benefits from the program. The report shall include, but is
- 16 not limited to, all of the following information:

- 25 from eligibility and the rationale for their removal.
- 26 (e) An explanation of any identified barriers to the
- 27 successful utilization of funds appropriated in part 1 for the

- 1 National Guard tuition assistance fund and applicable proposals for
- 2 legislative action to address those barriers.
- **3** (5) The general fund/general purpose funds appropriated in
- 4 part 1 for the National Guard tuition assistance fund shall be
- 5 deposited to the restricted Michigan National Guard tuition
- 6 assistance fund created in section 4 of the Michigan National Guard
- 7 tuition assistance act, 2014 PA 259, MCL 32.434. All funds in the
- 8 restricted Michigan National Guard tuition assistance fund are
- 9 appropriated and available for expenditure to support the Michigan
- 10 National Guard tuition assistance program.
- 11 Sec. 308. The department shall maintain the starbase program
- 12 at Air National Guard facilities, as provided under 10 USC 2193b,
- 13 to improve the knowledge, skills, and interest of students,
- 14 primarily in the fifth grade, in math, science, and technology. The
- 15 starbase program is to specifically target minority and at-risk
- 16 students for participation.

- 19 facility authority shall exercise certain regulatory and governance

- 26 and quality nursing and domiciliary care services at the Grand

- 2 achieve their highest potential of wellness, independence, self-
- 3 worth, and dignity.
- 4 (2) The department shall provide resources necessary to
- 5 provide nursing care services to veterans in accordance with
- 6 federal standards and provide the results of the annual USDVA
- 7 survey and certification as proof of compliance.
- 8 (3) Appropriations in part 1 for the Grand Rapids and the D.J.
- 9 Jacobetti homes for veterans shall not be used for any purpose
- 10 other than for veterans and veterans' families.
- 11 (4) Any contractor providing mental health services to the
- 12 Grand Rapids and D.J. Jacobetti homes for veterans shall utilize
- 13 mental health interventions that have been shown to be effective
- 14 with the conditions they are treating, in accordance with evidence-
- 15 based best practices supported by the USDVA-VHA, United States
- 16 Department of Defense, the Substance Abuse and Mental Health
- 17 Services Administration, the American Psychological Association,
- 18 and the National Association of Social Workers.
- 19 (5) Any contractor providing competency evaluated nursing
- 20 assistants (CENA) to the Grand Rapids home for veterans shall
- 21 ensure that each CENA has at least 8 hours of training on
- 22 information provided by the home.
- 23 (6) Any contractor providing competency evaluated nursing
- 24 assistants to the Grand Rapids home for veterans shall ensure that
- 25 each CENA has at least 1 eight-hour shift of shadowing at the
- 26 veterans' home.
- 27 (7) Any contractor providing competency evaluated nursing

- 1 assistants to the Grand Rapids home for veterans shall ensure that
- 2 each CENA is competent in the basic skills needed to perform his or
- 3 her assigned duties at the home.
- 4 (8) The Grand Rapids home for veterans shall provide each CENA
- 5 at least 12 hours of in-service training once that individual has
- 6 been assigned to the home.
- 7 (9) All complaints of abusive or neglectful care at the Grand
- 8 Rapids and the D.J. Jacobetti homes for veterans by a resident
- 9 member, a resident member's family or legal guardian, or staff of
- 10 the veterans' homes received by a supervisor shall be referred to
- 11 the director of nursing or his or her designee upon receipt of the
- 12 complaint. The director of nursing or his or her designee shall
- 13 report on not less than a monthly basis, except that the board of
- 14 managers may specify a more frequent reporting period to the home
- 15 administrator, board of managers, agency, subcommittees, senate and
- 16 house fiscal agencies, and state budget office the following
- 17 information:
- 18 (a) A description of the process by which resident members and

- 25 (10) The Grand Rapids and D.J. Jacobetti homes for veterans
- 26 shall provide an on-site, board-certified psychiatrist for all
- 27 resident members with mental health disorders in order to ensure

- 1 that those resident members receive needed services in a
- 2 professional and timely manner. The Grand Rapids and D.J. Jacobetti
- 3 homes for veterans shall provide all members and staff a safe and
- 4 secure environment.
- 5 (11) The Grand Rapids and D.J. Jacobetti homes for veterans
- 6 shall ensure that they effectively develop, execute, and monitor
- 7 all comprehensive care plans in accordance with federal regulations
- 8 and their internal policies, with a goal that a comprehensive care
- 9 plan is fully developed for all resident members.
- 10 (12) The Grand Rapids and D.J. Jacobetti homes for veterans
- 11 shall implement controls over their food, maintenance supplies,
- 12 pharmaceuticals, and medical supplies inventories.
- 13 (13) The Grand Rapids and D.J. Jacobetti homes for veterans
- 14 shall establish sufficient controls for calculating resident member
- 15 maintenance assessments in order to accurately calculate resident
- 16 member maintenance assessments for each billing cycle. The Grand
- 17 Rapids and D.J. Jacobetti homes for veterans shall establish
- 18 sufficient controls to ensure that all past due resident member
- 19 maintenance assessments are addressed within 30 days.
- 20 (14) The Grand Rapids and D.J. Jacobetti homes for veterans
- 21 shall establish sufficient controls over monetary donations and
- 22 donated goods.
- 23 (15) The Grand Rapids and D.J. Jacobetti homes for veterans
- 24 shall implement sufficient controls over the handling of resident
- 25 member funds to ensure the release of funds within 15 calendar days
- 26 upon the resident member leaving the home and to ensure that a
- 27 representative of a resident member is provided a full accounting

- 1 of that resident member's funds within 30 calendar days of the
- 2 death of that resident member.
- 3 (16) The MVAA shall post on its website all policies adopted
- 4 by the board of managers, the Michigan veterans' facility
- 5 authority, and the veterans' homes related to the administrative
- 6 operations of the veterans' homes.
- 7 (17) The process by which visitors, residents, and employees
- 8 of the Grand Rapids and D.J. Jacobetti homes for veterans may
- 9 register complaints shall be displayed in high-traffic areas
- 10 throughout the home.
- 11 (18) The MVAA shall report its findings regarding the state
- 12 veterans' homes' compliance with the requirements and standards
- 13 under this section in a quarterly report to the legislature and the
- 14 state budget office. The quarterly reports shall include, but are
- 15 not limited to, all of the following information:
- 16 (a) Quality of care metrics, including:
- 17 (i) The number of patient care hours and staffing levels
- 18 measured against USDVA-VHA standards.
- 19 (ii) Sentinel events reported to the USDVA.
- 20 (iii) Fall and wound reports.
- 21 (iv) Complaint reports, including abuse and neglect complaints
- 22 and outcomes of complaint investigations.
- (v) Additional minimum data set quality of care indicators
- 24 used to measure quality of care in long-term care facilities.
- 25 (b) Quarterly budget update.
- (c) An accounting of resident member populations at the Grand
- 27 Rapids and D.J. Jacobetti homes for veterans as follows:

- ${f 1}$  (i) By demographics, including period of service, gender, and
- **2** age.
- 3 (ii) By care setting, payment source, and associated revenue
- 4 projections.
- 5 (d) Updates related to the modernization of the Grand Rapids
- 6 and D.J. Jacobetti homes for veterans, including information
- 7 related to the following:
- 8 (i) Infrastructure/capital outlay improvements.
- 9 (ii) Information technology updates.
- 10 (iii) Financial management.
- 11 (e) Updates on corrective action status related to any audit
- 12 and survey findings until those findings have been fully addressed.
- 13 (19) The Grand Rapids and D.J. Jacobetti homes for veterans
- 14 shall provide to the subcommittees, the senate and house fiscal
- 15 agencies, and the state budget office the results of any annual or
- 16 for-cause survey conducted by the USDVA-VHA and any corresponding
- 17 corrective action plan. This information shall also be made
- 18 available publicly through the department's or MVAA's website.
- 19 (20) The MVAA shall provide to the legislature and the state
- 20 budget office quarterly reports of this part regarding the status
- 21 of Centers for Medicare and Medicaid certification efforts,
- 22 including, but not limited to, descriptions of incremental
- 23 milestones, associated expenditures, and the percentage of plan
- 24 completed.
- 25 Sec. 404. The department shall ensure that the quality of care
- 26 for members of the Grand Rapids and D.J. Jacobetti homes for
- 27 veterans shall meet or exceed the quality of care for the full

- 1 spectrum of health care services to meet or exceed the Centers for
- 2 Medicare and Medicaid Services certification standards. The
- 3 department shall provide a report as provided under section 216 of
- 4 this part to the subcommittees, which contains evidence that the
- 5 quality of care for the full spectrum of health care services has
- 6 met or exceeded Centers for Medicare and Medicaid Services
- 7 certification standards.
- 8 Sec. 405. (1) The MVAA shall provide a report, as provided
- 9 under section 216 of this part, on the financial status of the
- 10 Michigan veterans' trust fund, including the number and amount of
- 11 emergency grants, state administrative expenses, and county
- 12 administrative expenses.
- 13 (2) The Michigan veterans' trust fund board together with the
- 14 agency shall maintain the staffing and resources necessary to
- 15 process a minimum of 2,000 applications for veterans' trust fund
- 16 emergency grants.
- 17 (3) The Michigan veterans' trust fund board together with the
- 18 MVAA shall provide emergency grants for disbursement from the
- 19 Michigan veterans' trust fund, as provided under the following
- 20 program authorities:
- 21 (a) Sections 37, 38, and 39 of article IX of the state
- 22 constitution of 1963.
- 23 (b) 1946 (1st Ex Sess) PA 9, MCL 35.602 to 35.610.
- 24 (c) R 35.1 to R 35.7 of the Michigan Administrative Code.
- 25 (d) R 35.621 to R 35.623 of the Michigan Administrative Code.
- 26 (4) No later than December 1, the MVAA shall provide a
- 27 detailed report of the Michigan veterans' trust fund that includes,

- 1 for the immediately preceding fiscal year, information on grants
- 2 provided from the emergency grant program, including details
- 3 concerning the methodology of allocations, the selection of
- 4 emergency grant program authorized agents, a description of how the
- 5 emergency grant program is administered in each county, and a
- 6 detailed breakdown of trust fund expenditures for that year,
- 7 including the amount distributed to each county for administrative
- 8 costs and emergency grants. The report shall also include the
- 9 number of approved applications, by category of assistance, and the
- 10 number of denied applications, by reason of denial. The report
- 11 shall also provide an update on the department's efforts to reduce
- 12 program administrative costs and maintain the Michigan veterans'

- 15 Sec. 406. (1) The MVAA shall provide outreach services to
- 16 Michigan veterans to advise them on the benefits to which they are

- 19 (a) Maintain the staffing partnerships and other resources
- 20 necessary to develop and operate an outreach program that
- 21 communicates benefit eligibility information to at least 50% of
- 22 Michigan's population of veterans, as assessed by annual census
- estimates, with a goal of reaching 100% and enabling 100% to access
- 24 benefit information online.
- 25 (b) Communicate veteran benefit information pertaining to the

- 5 military discharge documents, and burial records that are currently
- 6 on paper and microfilm.
- 7 (e) Provide a report, as provided under section 216 of this
- 8 part, on the MVAA's performance on the performance measures,
- 9 outcomes, and initiatives developed by the agency in the strategic
- 10 plan required by section 501 of 2013 PA 9.
- 11 (f) Provide a report to the subcommittees, the senate and
- 12 house fiscal agencies, and the state budget office no later than
- 13 April 1 providing, to the extent known, data on the estimated
- 14 number of homeless veterans, by county, in this state.
- 15 (g) Provide the percentage of Michigan veterans contacted
- 16 through its outreach programs, with a goal of 90%, and report that
- 17 percentage to the subcommittees as provided under section 216 of
- 18 this part on the status of outreach.
- 19 (2) From the funds appropriated in part 1, the MVAA shall
- 20 provide for the regional coordination of services, as follows:
- (a) Regional coordinators shall be selected by the MVAA
- 22 through a staff augmentation service contract with VSOs or with a
- 23 Michigan-based nonprofit organization.
- 24 (b) Regional coordinators shall provide the following
- 25 services:

- 8 (a) Report the following information as provided in section
- **9** 216 of this part:
- 10 (i) The number of benefit claims, by type, submitted to the
- 11 USDVA by MVAA.
- (ii) The number of fully developed claims submitted to the
- 13 USDVA, with an overall goal of 40% of benefit claims submitted that
- 14 are considered fully developed by the USDVA.
- 15 (b) Maintain the staffing and resources necessary to process a
- 16 minimum of 500 claims per year.
- 17 (4) The MVAA shall maintain staffing and resources necessary
- 18 to develop and implement a process to ensure that all county
- 19 counselors receive the training and accreditation necessary to
- 20 provide quality services to veterans. The MVAA shall report
- 21 information as provided in section 216 of this part on the number
- 22 and percentage of county veterans counselors trained by the MVAA,
- 23 and the number and percentage who received funding from the MVAA to
- 24 attend training, with an overall goal of 100% of county veterans
- 25 counselors trained.
- 26 (5) From the funds appropriated in part 1 for MVAA, the MVAA
- 27 is authorized to expend up to \$50,000.00 to hire legal services to

- 1 represent veterans benefit cases before federal court to maintain
- 2 accreditation under 38 CFR 14.628(d)(1)(iv).
- 3 Sec. 407. (1) The MVAA shall disburse grants to achieve agency
- 4 goals and performance objectives in partnership with counties and
- 5 VSOs. Grants will be disbursed to fund programs and projects that
- 6 are determined by the agency to meet agency performance objectives
- 7 and ensure that grantees communicate the availability of emergency
- 8 grants through the Michigan veterans' trust fund. In disbursing
- 9 grants, the MVAA shall do all of the following:
- (a) Ensure that each grantee is issued performance standards.

- 7 (i) Report quarterly to the subcommittees and senate and house
- 8 fiscal agencies on grantee operations monitored under this
- 9 subsection, as provided in section 216 of this part.
- 10 (2) Grants awarded to a VSO by the MVAA shall provide for the
- 11 following, as developed by the MVAA:
- 12 (a) The provision of service to veterans statewide, using a
- 13 regional service delivery model, with services provided at
- 14 specified locations and times, including service provided in state
- 15 correctional facilities.
- 16 (b) The payment of an hourly service rate that shall not
- **17** exceed \$34.00 per hour.
- 18 (c) A specified number of service hours within each geographic
- 19 region of this state, with a statewide goal based on both
- 20 appropriations for the fiscal year ending September 30, 2020 for
- 21 the grant programs and the hourly service rate under subdivision
- 22 (b). The statewide goal will include service hours provided to
- 23 eligible incarcerated veterans within 1 year of their earliest
- 24 release date.
- 25 (d) Use of an MVAA-designated internet-based claims data
- 26 system.
- 27 (3) The MVAA shall report the following information as

- 1 provided in section 216 of this part:
- 2 (a) A summary of activities supported through the
- 3 appropriation in part 1 for grants, including the amount of
- 4 expenditures to date, number of service hours, number of claims for
- 5 benefits submitted by type of claim, and other information deemed
- 6 appropriate by the MVAA.
- 7 (b) The number and percentage of fully developed claims
- 8 submitted to the USDVA, and the number and percentage of fully
- 9 developed claims submitted that are considered fully developed by
- 10 the USDVA with an overall goal of 40%.
- Sec. 409. (1) The department shall enter into an interagency
- 12 agreement in cooperation with the department of health and human
- 13 services in order to work with the federal public assistance
- 14 reporting information system to identify Medicaid recipients who
- 15 are veterans and who may be eligible for federal veterans' health
- 16 care benefits or other benefits. The interagency agreement shall
- 17 include the specific outcome and performance reporting requirements
- 18 described in this section. The interagency agreement shall require
- 19 the department to provide all of the following items by January 1
- 20 for the current fiscal year to the subcommittees, the senate and
- 21 house fiscal agencies, and the policy offices:

- 6 (2) By October 1 of the current fiscal year, the department of
- 7 health and human services shall change the public assistance
- 8 application form from asking whether the prospective applicant was
- 9 a veteran to asking whether the applicant had ever served in the
- 10 military.
- Sec. 410. The general fund/general purpose funds appropriated
- 12 in part I for the county veteran service fund shall be deposited to
- 13 the restricted county veteran service fund created in section 3a of
- 14 1953 PA 192, MCL 35.623a. All funds in the restricted county
- 15 veteran service fund are appropriated and available for expenditure
- 16 to support county veteran service grants.
- Sec. 411. From the funds appropriated in part 1, the MVAA

- 8 maintenance National Guard shall be carried forward at the end of
- 9 the fiscal year consistent with section 248 of the management and
- 10 budget act, 1984 PA 431, MCL 18.1248.
- 11 (2) The appropriations for special maintenance National
- 12 Guard shall be expended in accordance with the requirements of
- 13 sections 302 and 305 of this part and shall be expended according
- 14 to the maintenance priorities of the department to repair and
- 15 modernize military training sites and support facilities, including
- 16 armories, which may include projects such as roof, HVAC, or boiler
- 17 replacement, interior renovations, facility expansion, improvements
- 18 to parking facilities, and other projects.
- 19 (3) The department shall provide a report as provided under
- 20 section 216 of this part providing information on the status,
- 21 projected costs, and projected completion date of current and
- 22 planned special maintenance projects at the armories and other
