- Sec. 202. The appropriations authorized under this part and
- 14 part 1 are subject to the management and budget act, 1984 PA 431,
- **15** MCL 18.1101 to 18.1594.
- Sec. 203. As used in this part and part 1:
- 17 (a) "CJIS" means Criminal Justice Information Systems.
- 18 (b) "Core service" means that term as defined in section 373
- 19 of the management and budget act, 1984 PA 431, MCL 18.1373.
- (c) "Department" means the department of state police.
- 21 (d) "Director" means the director of the department.
- (e) "DNA" means deoxyribonucleic acid.
- 23 (f) "DTMB" means the department of technology, management, and
- 24 budget.
- 25 (g) "FTE" means full-time equated.
- 26 (h) "IDG" means interdepartmental grant.
- 27 (i) "MCOLES" means the Michigan commission on law enforcement

- 1 standards.
- 2 (j) "Subcommittees" means the subcommittees of the senate and
- 3 house standing committees on appropriations with jurisdiction over
- 4 the budget for the department.
- 5 (k) "Support service" means an activity required to support
- 6 the ongoing delivery of core services.
- 7 Sec. 204. The department and agencies receiving appropriations
- 8 in part 1 shall use the internet to fulfill the reporting
- 9 requirements of this part. This requirement may include
- 10 transmission of reports via electronic mail to the recipients
- 11 identified for each reporting requirement, or it may include
- 12 placement of reports on an internet or intranet site.
- Sec. 205. Funds appropriated in part 1 shall not be used for
- 14 the purchase of foreign goods or services, or both, if
- 15 competitively priced and of comparable quality American goods or
- 16 services, or both, are available. Preference shall be given to
- 17 goods or services, or both, manufactured or provided by Michigan
- 18 businesses, if they are competitively priced and of comparable
- 19 quality. In addition, preference shall be given to goods or
- 20 services, or both, that are manufactured or provided by Michigan
- 21 businesses owned and operated by veterans, if they are
- 22 competitively priced and of comparable quality.
- 23 Sec. 206. The director shall take all reasonable steps to

- 23 the attorney general authorizes.
- Sec. 209. Not later than November 30, the state budget office
- 25 shall prepare and transmit a report that provides for estimates of
- 26 the total general fund/general purpose appropriation lapses at the
- 27 close of the prior fiscal year. This report shall summarize the

- 1 projected year-end general fund/general purpose appropriation
- 2 lapses by major departmental program or program areas. The report
- 3 shall be transmitted to the chairpersons of the senate and house

- 6 Sec. 210. (1) In addition to the funds appropriated in part 1,

- 18 Sec. 211. The department shall cooperate with the DTMB to
- 19 maintain a searchable website accessible by the public at no cost

- 22 (b) Fiscal year-to-date expenditures by appropriation unit.
- (c) Fiscal year-to-date payments to a selected vendor,
- 24 including the vendor name, payment date, payment amount, and
- 25 payment description.
- 26 (d) The number of active department employees by job
- 27 classification.

- 1 (e) Job specifications and wage rates.
- 2 Sec. 212. Within 14 days after the release of the executive
- 3 budget recommendation, the department shall cooperate with the
- 4 state budget office to provide the senate and house appropriations
- 5 chairs, the senate and house appropriations subcommittees chairs,
- 6 and the senate and house fiscal agencies with an annual report on
- 7 estimated state restricted fund balances, state restricted fund
- 8 projected revenues, and state restricted fund expenditures for the
- 9 fiscal years ending September 30, 2019 and September 30, 2020.
- 10 Sec. 213. The department shall maintain, on a publicly
- 11 accessible website, a department scorecard that identifies, tracks,
- 12 and regularly updates key metrics that are used to monitor and
- improve the department's performance.
- 14 Sec. 214. Total authorized appropriations from all sources
- 15 under part 1 for legacy costs for the fiscal year ending September
- 16 30, 2020 are estimated at \$137,272,300.00. From this amount, total
- 17 agency appropriations for pension-related legacy costs are
- 18 estimated at \$74,914,400.00. Total agency appropriations for
- 19 retiree health care legacy costs are estimated at \$62,357,900.00.
- 20 Sec. 215. Based on the availability of federal funding and
- 21 demonstrated need, as indicated by applications submitted to the
- 22 state court administrative office, the department shall provide
- 23 \$1,500,000.00 in Byrne justice assistance grant program funding to
- 24 the judiciary by interdepartmental grant.
- 25 Sec. 216. A department or state agency shall not take
- 26 disciplinary action against an employee for communicating with a
- 27 member of the legislature or his or her staff.

- 1 Sec. 217. The department shall provide biannual reports to the
- 2 subcommittees, the senate and house fiscal agencies, and the state
- 3 budget office that provide the following data:
- 4 (a) A list of major work projects, including the status of
- 5 each project.
- 6 (b) The department's financial status, featuring a report of
- 7 budgeted versus actual expenditures by part 1 line item including a
- 8 year-end projection of budget requirements. If projected department
- 9 budget requirements exceed the allocated budget, the report shall
- 10 include a plan to reduce overall expenses while still satisfying
- 11 specified service level requirements.
- 12 (c) A report on the performance metrics cited or information
- 13 required to be reported in this part, reasons for nonachievement of
- 14 metric targets, and proposed corrective actions.
- Sec. 218. The appropriations in part 1 are for the core
- 16 services, support services, and work projects of the department,
- 17 including, but not limited to, the following core services:
- 18 (a) State security operations.
- 19 (b) Training.
- 20 (c) MCOLES.
- **21** (d) CJIS.
- (e) Forensic analysis and biometric identification.
- 23 (f) Post operations and investigative services.
- 24 (g) Special operations.
- 25 (h) Intelligence operations.
- (i) Commercial vehicle regulation and enforcement.
- (j) Emergency management and homeland security.

- 1 (k) Highway safety planning.
- 2 (l) Secondary road patrol program.
- 3 Sec. 219. The department shall notify the subcommittees, the
- 4 chairpersons of the senate and house standing committees on
- 5 appropriations, and the senate and house fiscal agencies not less
- 6 than 90 days before recommending to close or consolidate any state
- 7 police post. The notification shall include a local and state
- 8 impact study of the proposed post closure or consolidation.
- 9 Sec. 220. At least 90 days before beginning any effort to
- 10 privatize, the department shall submit a complete project plan to
- 11 the subcommittees and the senate and house fiscal agencies. The
- 12 plan shall include the criteria under which the privatization
- 13 initiative will be evaluated. The evaluation shall be completed and
- 14 submitted to the subcommittees and the senate and house fiscal
- 15 agencies within 30 months.
- Sec. 221. (1) When the department provides contractual
- 17 services to a local unit of government, the department shall be
- 18 reimbursed for all costs incurred in providing the services,
- 19 including, but not limited to, retirement and overtime costs.
- 20 (2) The department shall define service cost models for those
- 21 services requiring reimbursement.
- 22 (3) Contractual services provided to an entity other than a
- 23 local unit of government may be provided by department personnel,
- 24 but only on an overtime basis outside the normal work schedule of
- 25 the personnel.
- 26 (4) This section does not apply to services provided to state

- 15 communications system and shall report user issues to the DTMB.
- 16 Sec. 223. The department may establish and collect fees for
- 17 publications, videos, conferences, workshops, and related
- 18 materials. Collected fees shall be used to offset expenditures for
- 19 costs of the publications, videos, workshops, conferences, and
- 20 related materials. The department shall not collect fees under this
- 21 section that exceed the cost of the expenditures.
- 22 Sec. 224. (1) The department may accept monetary and
- 23 nonmonetary gifts, bequests, donations, contributions, or grants
- 24 from any private or public source to support, in whole or in part,
- 25 a departmental function or program. The department shall expend or
- 26 use such gifts, bequests, donations, contributions, or grants for
- 27 the purposes designated by the private or public source, if the

- 1 purpose is specified.
- 2 (2) Revenue collected by the department under this section
- 3 that is unexpended and unencumbered shall not lapse to the general
- 4 fund but shall be carried forward to the subsequent fiscal year.
- **5** Sec. 225. (1) Federal revenues authorized by and available

- 25 vendors or service providers to protect data shared with them,
- 26 ensuring that when personal data is collected, but no longer
- 27 utilized by the department, that reasonable steps be taken to

- 1 securely destroy records containing personal information when it is
- 2 to be discarded so that the information is rendered indecipherable
- 3 and is not sold for marketing or other purposes. In addition, the
- 4 department shall provide written notification to any data subject
- 5 whose sensitive personal information is accessed or acquired by an
- 6 unauthorized person.
- 7 Sec. 227. The department shall utilize attrition savings from
- 8 the appropriations in part 1 to conduct an attrition school during
- 9 the 2019-2020 fiscal year that will graduate at least 70 new
- 10 troopers.
- 11 Sec. 228. A law enforcement officer or a motor carrier officer
- 12 funded under part 1 shall not be required to issue a predetermined
- 13 or specified number of citations for violations of the Michigan
- 14 vehicle code, 1949 PA 300, MCL 257.1 to 257.923, or of local
- 15 ordinances substantially corresponding to provisions of the
- 16 Michigan vehicle code, 1949 PA 300, MCL 257.1 to 257.923, including
- 17 parking or standing violations. A law enforcement officer's or
- 18 motor carrier officer's performance evaluation system shall not
- 19 require a predetermined or specified number of citations to be
- 20 issued.

- 26 (2) The department shall provide performance data, as provided

- 1 under section 217 of this part, for average classroom occupancy
- 2 rate, with an annual goal of at least 55%.
- 3 (3) The department shall submit a report to the subcommittees
- 4 and the senate and house fiscal agencies within 60 days of the
- 5 conclusion of any trooper, motor carrier, or state properties
- 6 security recruit school. The report shall include the following:
- 7 (a) The number of veterans and the number of MCOLES-certified
- 8 police officers who were admitted to and the number who graduated
- 9 from the recruit school.
- 10 (b) The total number of recruits who were admitted to the
- 11 school, the number of recruits who graduated from the school, and
- 12 the location at which each of these recruits is assigned.
- 13 (4) The department shall distribute and review course
- 14 evaluations to ensure that quality training is provided.
- 15 Sec. 402. (1) In accordance with applicable state and federal
- 16 laws and regulations, the department shall maintain and ensure
- 17 compliance with CJIS databases and applications in the support of
- 18 public safety and law enforcement communities.
- 19 (2) The department shall improve the accuracy, timeliness, and
- 20 completeness of criminal history information by conducting a
- 21 minimum of 30 outreach activities targeted to criminal justice
- 22 agencies.
- 23 (3) The department shall provide for the compilation of crime
