## SENATE SUBSTITUTE FOR HOUSE BILL NO. 4899

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 236 (MCL 257.236), as amended by 2000 PA 64.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 236. (1) If ownership of a vehicle passes by operation of 2 law, upon furnishing satisfactory proof of that ownership to the 3 secretary of state, the person acquiring the vehicle may procure a title to the vehicle regardless of whether a certificate of title 4 has ever been issued. Upon death of an owner of a registered 5 vehicle, the license plate assigned to the vehicle, unless the 6 7 vehicle is destroyed, is a valid registration until the end of the registration year or until the personal representative of the 8 owner's estate transfers ownership of the vehicle. 9

(2) If an owner of 1 or more vehicles , which vehicles do not 1 have a total value of more than \$60,000.00, dies and the owner does 2 3 not leave other property that requires **the** issuance of letters as provided in under section 3103 of the estates and protected 4 individuals code, 1998 PA 386, MCL 700.3103, the owner's surviving 5 6 spouse, or an heir of the owner in the order specified in section 7 2103 of the estates and protected individuals code, 1998 PA 386, 8 MCL 700.2103, may apply for a title, after furnishing providing the 9 secretary of state with proper proof of the death of the registered 10 owner, attaching to the proof a certification setting forth the 11 fact that the applicant is the surviving spouse or an heir. Upon proper petition, the secretary of state shall furnish provide the 12 13 applicant with a certificate of title for that vehicle or vehicles, 14 if the total value of the vehicle or vehicles, based on the 15 calendar year of the deceased owner's death, does not exceed the following dollar amount, as applicable: 16

17 (a) For the calendar years beginning January 1, 2022 and18 January 1, 2023, \$100,000.00.

(b) For the calendar year beginning January 1, 2024 and each 19 20 calendar year thereafter, a dollar amount equal to the product of 21 the dollar amount applicable to the immediately preceding calendar 22 year multiplied by the cost-of-living adjustment factor, rounded to 23 the nearest \$1,000.00. Beginning with the dollar amount in effect 24 on January 1, 2024 and annually thereafter, the department of 25 treasury shall certify and publish the dollar amount applicable for 26 each calendar year no later than December 1 of the prior calendar 27 year.

## (3) As used in this section:

(a) "Cost-of-living adjustment factor" means a fraction in

which the numerator is the United States Consumer Price Index for
the year before the prior calendar year and the denominator is the
United States Consumer Price Index for the 2021 calendar year.

4 (b) "United States Consumer Price Index" means the annual 5 average of the United States Consumer Price Index for all urban 6 consumers as defined and reported by the United States Department 7 of Labor, Bureau of Labor Statistics, or its successor agency.

8 Enacting section 1. This amendatory act takes effect 90 days9 after the date it is enacted into law.
