THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Sections 325, 501, and 604 of Act No. 86 of the
- 2 Public Acts of 1980, as amended by Act No. 152 of the Public Acts
- 3 of 1990, being sections 316.325, 316.501, and 316.604 of the
- 4 Michigan Compiled Laws, are amended to read as follows:

- 5 Sec. 325. A person authorized by the director to issue
- 6 licenses and passbooks may retain 8% of the license fee and
- 7 passbook fee for each license and passbook sold by that person
- 8 and 8% of the amount of each conservation law enforcement stamp

- 1 AND EACH FISHERIES HABITAT IMPROVEMENT STAMP sold by that
- 2 person.
- 3 Sec. 501. (1) The director shall prepare the passbook and
- 4 licenses to comply with this act and may authorize persons to
- 5 issue passbooks and licenses.
- 6 (2) A passbook shall provide the following information:
- 7 (a) The name of the applicant.
- 8 (b) The height and weight of the applicant.
- 9 (c) The address of the applicant.
- (d) The birth date of the applicant.
- (e) The driver's license number of the applicant, if the
- 12 applicant has a driver's license.
- (f) The date and time of issuance of the passbook or

- (q) The identification code of the person issuing the

- 17 (h) The form of proof of eligibility to receive a passbook

- 1 Sec. 604. (1) In addition to each license and stamp fee
- 2 prescribed in article 3, a person shall be charged a 35-cent fee
- 3 that shall be transmitted to the department for deposit in the

- 5 (2) The wildlife resource protection fund is created as a
- 6 separate fund within the state treasury. The state treasurer
- 7 shall credit the money received from the department under this

- 26 amount to the wildlife resource protection fund to be expended
- 27 for the purposes provided in subsection (2). A person who wishes

- 7 AMOUNT TO THE FISHERIES HABITAT IMPROVEMENT GRANT FUND THAT IS
- 8 CREATED AS A SEPARATE FUND WITHIN THE STATE TREASURY. THIS FUND
- 9 SHALL CONSIST OF THE MONEY GENERATED FROM VOLUNTARY CONTRIBUTIONS
- 10 TO THE FISHERIES HABITAT IMPROVEMENT PROGRAM FUND AND SHALL BE
- 11 APPROPRIATED BY THE LEGISLATURE FOR EXPENDITURE BY THE DEPARTMENT
- 12 IN THE FORM OF GRANTS TO ORGANIZATIONS AND SPORTS CLUBS TO PRO-

- 16 (C) PATHS, STAIRWAYS, FENCES, AND RELATED MEANS TO REGULATE
- 17 OR INFLUENCE HUMAN ACTIVITIES.
- 18 (D) STREAM BANK STABILIZATION.
- 19 (E) SEDIMENT TRAPS IN CONJUNCTION WITH EROSION CONTROL.
- 20 (F) SPAWNING RIFFLES.
- 21 (G) TAG ALDER CLEARINGS.
- 22 (H) FISH COVER STRUCTURES.
- 23 (I) REARING PONDS OR MARSHES.
- 24 (J) ROUGH FISH BARRIERS.
- 25 (K) SMALL SCALE FISHWAYS.
- 26 (1) CULVERT MODIFICATIONS.

- 1 (M) INNOVATIVE LAKE AND STREAM HABITAT ENHANCEMENT.
- 2 (N) INNOVATIVE FISHERIES.
- 3 (5) BEFORE A PROJECT MAY BE CONSIDERED FOR A FISHERIES HABI-
- 4 TAT IMPROVEMENT GRANT PROVIDED FOR IN SUBSECTION (4), THE PROJECT
- 5 MUST INDICATE ALL OF THE FOLLOWING:
- 6 (A) CONSISTENCY WITH THE POLICIES, MANAGEMENT GOALS, AND
- 7 MANAGEMENT OBJECTIVES OF THE FISHERIES DIVISION OF THE

- 9 (B) PUBLIC SUPPORT.
- 10 (C) HANDICAP ACCESSIBILITY, IF FEASIBLE AND APPLICABLE TO
- 11 THE NATURE OF THE PROJECT.
- 12 (D) THAT THE PROJECT WILL BE INITIATED AND COMPLETED WITHIN
- 13 THE GRANT CYCLE OF 2 YEARS.
- 14 (E) A POSITIVE BENEFIT TO COST RATIO.
- 15 (F) EVIDENCE OF LAND CONTROL FOR THE PROPOSED AREA. A PREF-
- 16 ERENCE FOR FEE OWNERSHIP WILL EXIST BUT A LONG-TERM LEASE IS ALSO
- 17 ACCEPTABLE.
- 18 (G) COMPLETION OF WORK UNDER ANY PRIOR FISHERIES HABITAT
- 19 IMPROVEMENT GRANT.
- 20 (H) 25% MATCHING FUNDS, OR SERVICES THAT ARE DETERMINED BY
- 21 THE DEPARTMENT TO BE APPROPRIATE.
- 22 (6) -(4) Subsection (1) shall not apply to a license or
- 23 stamp which is issued to a senior citizen.
- 24 (7) $\frac{-(5)}{}$ The director shall annually report to the legisla-
- 25 ture on the expenditures from the wildlife resource protection
- 26 fund.
