- 5 TARY RESERVE MAY APPLY TO THE SECRETARY OF STATE FOR A SPECIAL
- 6 REGISTRATION PLATE, WHICH SHALL DISPLAY AN APPROPRIATE VIGNETTE
- 7 PRECEDING THE REGISTRATION NUMBERS AND SHALL HAVE THE WORDS
- 8 "MILITARY RESERVIST" INSCRIBED BENEATH THE REGISTRATION NUMBERS.

- 1 (2) APPLICATION FOR A SPECIAL REGISTRATION PLATE SHALL BE ON
- 2 A FORM PRESCRIBED BY THE SECRETARY OF STATE, AND SHALL BE

- 22 MISDEMEANOR.
- 23 (5) THE SPECIAL REGISTRATION PLATE ISSUED UNDER THIS SECTION
- 24 EXPIRES ON THE BIRTHDAY OF THE VEHICLE OWNER. WHEN NEW PLATES
- 25 ARE ISSUED BY THE SECRETARY OF STATE, APPLICATION FOR RENEWAL OF
- 26 THE SPECIAL REGISTRATION PLATE SHALL BE ACCOMPANIED BY A \$5.00

- 1 SERVICE FEE. THE APPLICANT SHALL NOT BE REQUIRED TO FURNISH THE
- 2 PROOF REQUIRED BY SUBSECTION (2).
