A bill to amend the title and section 3 of Act No. 256 of the Public Acts of 1988, entitled "Wildlife conservation act," being section 300.253 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. The title and section 3 of Act No. 256 of the

- 5 An act to provide for the conservation of animals and the

- 1 natural resources and certain other persons; to prescribe
- 2 penalties and provide remedies; and to repeal certain acts and
- 3 parts of acts on specific dates.
- 4 Sec. 3. (1) "Animals" means wild birds and wild mammals.
- 5 (2) "Bag limit" means the number of animals which may be
- 6 taken and possessed as determined by the commission.
- 7 (3) "Bow" means a device for propelling an arrow from a
- 8 string drawn, held, and released by hand where the force used to
- 9 hold the string in the drawn position is provided by the archer's
- 10 muscles.
- 11 (4) "Buy" or "sell" means an exchange or attempt or offer to
- 12 exchange for money, barter, or for anything of value.
- 13 (5) "Chase" means to follow animals with dogs or other
- 14 animals.
- 15 (6) "Commission" means the commission of natural resources
- 16 CONSERVATION AND RECREATION.
- (7) "Department" means the department of natural resources.
- (8) "Director" means the director of the department.
- (9) "Firearm" means a weapon from which a dangerous projec-
- 20 tile may be propelled by using explosives, gas, or air as a means
- 21 of propulsion. Firearm does not include a smooth bore rifle or
- 22 handgun designed and manufactured exclusively for propelling BB's
- 23 not exceeding .177 caliber by means of a spring, air, or gas.
