## HOUSE BILL No. 4795

May 6, 1991, Introduced by Rep. Power and referred to the Committee on State Affairs.

A bill to authorize the state administrative board, on behalf of the state, to convey certain state owned property located in Grand Traverse county; to provide conditions for the conveyance; and to provide for disposition of the revenue derived from the conveyance.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 1. The state administrative board, on behalf of the 2 state, may convey to Grand Traverse county, for consideration of $3 \$ 1.00$, property now under the jurisdiction of the department of A social services and located adjacent to the Traverse City 5 regional psychiatric hospital in the township of Garfield, Grand 6 Traverse county, Michigan, and, subject to the conveyance pro7 vided for in section 2 , more specifically described as follows: 8 Commencing at the NE corner of Sec. 8, T27N, R11W, Grand 9 Traverse County, thence S01 degrees 55'09"W along the east line

1 of Sec. 81094.21 feet to a found $1-1 / 4 "$ pipe and the point of 2 beginning, thence S01 degrees 51'26"W along the east line of 3 Sec. 8256.70 feet to a found bronze-capped State of Michigan 4 monument, thence SO1 degrees $52^{\prime} 30^{\prime \prime} \mathrm{W}$ along the east line of 5 Sec. 840.29 feet to the center of old road (Brockway Hill Road 6 road has since been relocated as County Road 610), thence N81 7 degrees 57'37"W 210.35 feet to a found one-inch pipe, thence N50

8 degrees 27 '52"W 181.10 feet to a set $5 / 8^{\prime \prime} \times 36 "$ rerod, thence N 26
9 degrees 07 '30"E 275.00 feet to a found $3 / 4$ " pipe at old fence 10 corner, thence 568 degrees $09^{\prime} 50$ "E 254.79 feet to point of begin11 ning - containing 2.26 acres. Also, beginning at the NW corner 12 of Sec. 9 T27N, R11W, Grand Traverse County, thence S01 degrees 13 55'09"W along the west line of Sec. 91094.21 feet to a found 14 1-1/4" pipe, thence S01 degrees 51'26"W along the west line of 15 Sec. 9256.70 feet to a bronze-capped State of Michigan monument, 16 thence S01 degrees $52^{\prime} 30^{\prime \prime W} \mathrm{~W}$ along the west line of Sec. 933.83 17 feet to the center of existing blacktop county road (County Road 18 610), thence along the center line of said County Road N66 19 degrees 52 '36"E 270.81 feet to the P.C. of a 1145.92 -foot radius 20 curve to the left, thence continuing along the centerline of said 21 County Road 610 northeasterly along the arc of said 1145.92-foot 22 radius curve 679.32 feet to the P.T. of curve the chord bearing 23 and distance of said curve being N49 degrees 53'35"E 669.42 feet, 24 thence continuing along the centerline of said County Road 610, 25 N32 degrees 54'39"E 867.24 feet to the P.C. of a 781.31-foot 26 radius curve to the left, thence continuing along the centerline 27 of said County Road 610 northeasterly along the arc of said
1781.31 -foot radius curve 223.87 feet to the north of Sec. 9 the 2 chord bearing and distance of said curve being $N 24$ degrees 342 '46"E 223.11 feet, thence 586 degrees $13^{\prime \prime} 41^{\prime \prime} \mathrm{W}$ along the north 4 line of Sec. 9 and approximate centerline of Cedar Run Road 51282.23 feet to the point of beginning - containing 26.40 acres. 6 Sec. 2. The state administrative board, on behalf of the 7 state, shall convey to the Grand Traverse county road commission, 8 for consideration of $\$ 1.00$, part of the property described in 9 section 1 , for the purpose of building a road, that part being 10 more particularly described as follows:

11 That portion of the Northwest one quarter of Section 9, Town 27
12 North, Range 11 West lying west of North Long Lake Road, more 13 fully described as:

14 Commencing at the Northwest corner of said Section 9 as the 15 point of beginning; thence South on the West section line 50.00

16 feet; thence Southeasterly 772.28 feet along a 1246.43 foot
17 radius curve to the right (Delta= $35^{\circ}-30^{\prime}$; Long chord bears 18 S760-05'-49"E., measured from a line parallel to the north sec19 tion line which is an assumed bearing of N86º ${ }^{\circ} 9^{\prime-11 " E, ~ 759.98 ~}$ 20 feet); thence South 580-20'-49" E, 275 feet, more or less to the 21 center of said North Long Lake Road; thence Northeasterly along 22 the existing centerline of North Long Lake Road until its inter23 section with the north section line of said Section 9 ; thence $248^{\circ}-09^{\prime}-11^{\prime \prime} W$ (assumed) along the north section line of said 25 Section 9, to the point of beginning as the point of ending.

Sec. 3. The conveyances authorized by sections 1 and 2 27 shall provide that the land be used exclusively for public

1 purposes and that upon termination of this use, the property 2 conveyed shall revert immediately to the state, with the state

3 assuming no liability for improvements made at the grantee's
4 expense.
5 Sec. 4. The conveyances authorized by this act shall be by
6 quitclaim deed approved by the attorney general and shall reserve
7 to the state all rights to coal, oil, gas, and other minerals
8 found on, within, or under the property conveyed.
9 Sec. 5. The revenue received under this act shall be depos10 ited in the state treasury and credited to the general fund.
