- 1 (2) A bicycle or motorcycle shall not be used to carry more 2 persons at 1 time than the number for which it is designed and 3 equipped.
- 4 (3) A moped shall not be used to carry more than 1 person at 5 a time.
- 6 (4) A person operating or riding on a motorcycle, and any
- 7 A person less than 19 years of age operating a moped on a public
- 8 thoroughfare shall wear a crash helmet on his or her head. Crash

- 3 INTERSTATE HIGHWAY.
- 4 (B) IN AN AREA BOUNDED ON THE SOUTH BY THE INTERSECTION OF
- 5 I-75 AND I-275; THEN WEST AND NORTH ON I-275 TO I-696; THEN EAST
- 6 ON I-696 TO US-24; THEN NORTH ON US-24 TO M-59; AND THEN EAST ON
- 7 M-59 TO LAKE ST. CLAIR.
