- 5 SEC. 5857. (1) NOTWITHSTANDING A PERIOD OF LIMITATION OTH-
- 6 ERWISE PRESCRIBED BY THIS ACT, A PERSON MAY BRING AN ACTION TO
- 7 RECOVER DAMAGES FOR INJURY THAT RESULTS FROM AN ACT OF SEXUAL
- 8 ABUSE COMMITTED AGAINST THE PLAINTIFF BY THE DEFENDANT IF THE
- 9 ACTION IS COMMENCED WITHIN 3 YEARS AFTER THE PLAINTIFF ACHIEVES

- 1 THE AGE OF MAJORITY OR WITHIN 3 YEARS AFTER THE PLAINTIFF
- 2 DISCOVERS OR SHOULD HAVE DISCOVERED THAT THE SEXUAL ABUSE CAUSED

- 20 OF 1931, BEING SECTIONS 750.520A TO 750.520G OF THE MICHIGAN
- 21 COMPILED LAWS.
- 22 (C) A PRIOR LAW SIMILAR TO A SECTION CITED IN SUBDIVISION
- 23 (A) OR (B) THAT WAS EFFECTIVE AT THE TIME OF THE CONDUCT.
