- Sec. 1210. (1) An application for admission to examination,

- 6 gist, or manicurist shall be in writing on a -blank FORM pre-
- 7 pared and furnished by the department. An application shall con-
- 8 tain proof of the qualifications of the applicant for examination
- 9 as provided in this article, and shall be verified by the oath of
