## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 451 of the Public Acts of 1976, as

- 3 Compiled Laws, is amended by adding section 1165 to read as
- 4 follows:
- 5 SEC. 1165. (1) NOT LATER THAN JANUARY 1, 1993, THE BOARD OF
- 6 A SCHOOL DISTRICT SHALL DEVELOP AND MAKE AVAILABLE TO THE PUBLIC
- 7 A PLAN FOR SUPPORTING THE EFFORTS OF FAMILY UNITS BY
- 8 INCORPORATING INTO PUPIL INSTRUCTION THROUGHOUT GRADES K THROUGH
- 9 12 THE TEACHING OF ETHICS AND VALUES.

- 1 (2) NOT LATER THAN THE BEGINNING OF ITS 1993-1994 SCHOOL
- 2 YEAR, AFTER AN OPPORTUNITY FOR PUBLIC COMMENT, THE BOARD OF A
- 3 SCHOOL DISTRICT SHALL IMPLEMENT A PLAN FOR TEACHING ETHICS AND
- 4 VALUES AS DESCRIBED IN SUBSECTION (1).

- 11 (B) INTEGRITY: TO BE PRINCIPLED, HONORABLE, AND UPRIGHT; TO
- 12 NOT BE TWO-FACED OR UNSCRUPULOUS.
- 13 (C) PROMISE-KEEPING: TO BE WORTHY OF TRUST, KEEP PROMISES,
- 14 FULFILL COMMITMENTS, AND ABIDE BY THE SPIRIT AS WELL AS THE
- 15 LETTER OF AN AGREEMENT.
- \*16 (D) LOYALTY: TO BE FAITHFUL AND LOYAL TO FAMILY, FRIENDS,
  - 17 EMPLOYERS, CLIENTS, AND COUNTRY.
  - 18 (E) FAIRNESS: TO BE FAIR AND OPEN-MINDED, WILLING TO ADMIT
  - 19 ERROR, AND, IF APPROPRIATE, CHANGE POSITIONS AND BELIEFS; TO
  - 20 DEMONSTRATE A COMMITMENT TO JUSTICE AND THE EQUAL TREATMENT OF
  - 21 INDIVIDUALS.
  - 22 (F) CARING FOR OTHERS: TO BE CARING, KIND, AND COMPASSION-
  - 23 ATE; TO SHARE; TO BE GIVING AND OF SERVICE TO OTHERS; TO HELP
  - 24 THOSE IN NEED AND AVOID HARMING OTHERS.
  - 25 (G) RESPECT FOR OTHERS: TO DEMONSTRATE RESPECT FOR OTHER
  - 26 PEOPLE'S PROPERTY, HUMAN DIGNITY, AND PRIVACY; TO BE COURTEOUS,
  - 27 PROMPT, AND DECENT; TO NOT PATRONIZE, EMBARRASS, OR DEMEAN.

- 1 (H) RESPONSIBLE CITIZENSHIP: TO OBEY THE LAWS AND, IF A LAW
- 2 IS UNJUST, OPENLY PROTEST IT; TO EXERCISE ALL DEMOCRATIC RIGHTS
- 3 AND PRIVILEGES RESPONSIBLY BY PARTICIPATION THROUGH VOTING AND
- 4 EXPRESSING INFORMED VIEWS, SOCIAL CONSCIOUSNESS, AND PUBLIC SERV-
- 5 ICE; WHEN IN A POSITION OF LEADERSHIP OR AUTHORITY, TO OPENLY
- 6 RESPECT AND HONOR DEMOCRATIC PROCESSES OF DECISION MAKING, AVOID
- 7 UNNECESSARY SECRECY OR CONCEALMENT OF INFORMATION, AND ASSURE
- 8 THAT OTHERS HAVE ALL THE INFORMATION THEY NEED TO MAKE INTELLI-
- 9 GENT CHOICES AND EXERCISE THEIR RIGHTS.
- 10 (I) PURSUIT OF EXCELLENCE: TO PURSUE EXCELLENCE IN ALL MAT-
- 11 TERS AND IN MEETING PERSONAL AND PROFESSIONAL RESPONSIBILITIES;
- 12 TO BE DILIGENT, RELIABLE, INDUSTRIOUS, AND COMMITTED; TO PERFORM
- 13 ALL TASKS TO THE BEST OF ONE'S ABILITY, DEVELOP AND MAINTAIN A
- 14 HIGH DEGREE OF COMPETENCE, AND BE WELL INFORMED AND WELL PRE-
- 15 PARED; TO NOT BE CONTENT WITH MEDIOCRITY; TO NOT STRIVE TO "WIN
- 16 AT ANY COST".
- 17 (J) ACCOUNTABILITY: TO BE ACCOUNTABLE AND ACCEPT RESPONSI-
- 18 BILITY FOR DECISIONS, FOR THE FORESEEABLE CONSEQUENCES OF ACTIONS
- 19 AND INACTIONS, AND FOR SETTING AN EXAMPLE FOR OTHERS. TO AVOID
- 20 EVEN THE APPEARANCE OF IMPROPRIETY AND TO TAKE NECESSARY ACTION
- 21 TO CORRECT OR PREVENT INAPPROPRIATE CONDUCT OF OTHERS.
