

## **SENATE BILL No. 628**

May 6, 1993, Introduced by Senators CHERRY, O'BRIEN and KOIVISTO and referred to the Committee on Transportation and Tourism.

A bill to amend sections 226 and 227a of Act No. 288 of the Public Acts of 1967, entitled as amended "Subdivision control act of 1967," being sections 560.226 and 560.227a of the Michigan Compiled

Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Section 1. Sections 226 and 227a of Act No. 288 of the
 Public Acts of 1967, being sections 560.226 and 560.227a of the
 Michigan Compiled Laws, are amended to read as follows:

Sec. 226. (1) Upon trial and hearing of the action, the
5 court may order a recorded plat or any part of it to be vacated,
6 corrected, or revised, with the following exceptions:

7 (a) A part of a state highway or federal aid road shall not
8 be vacated, corrected, or revised except by the STATE

3 (b) A part of a county road shall not be vacated, corrected,
4 or revised except by the county road commission having jurisdic5 tion PURSUANT TO CHAPTER IV OF ACT NO. 283 OF THE PUBLIC ACTS OF
6 1909, BEING SECTIONS 224.1 TO 224.32 OF THE MICHIGAN COMPILED
7 LAWS.

8 (c) A part of a street or alley under the jurisdiction of a
9 city, village, or township and a part of any public walkway,
10 park, or public square or any other land dedicated to the public
11 for purposes other than pedestrian or vehicular travel shall not
12 be vacated, corrected, or revised under this section except by
13 both a resolution or other legislative enactment duly adopted by
14 the governing body of the municipality and by court order.
15 However, neither this section nor any other section shall limit
16 or restrict the right of a municipality under sections 256 and
17 257 to vacate the whole or any part of a street, alley, or other
18 land dedicated to the use of the public.

1 TRANSFER TITLE TO A LOCAL UNIT OF GOVERNMENT, OR DEED THE 2 PROPERTY TO THE ADJACENT PROPERTY OWNERS.

3 (3) -(2) A judgment under this section vacating, correct4 ing, or revising a highway, road, street, or other land dedicated
5 to the public and being used by a public utility for public util6 ity purposes shall reserve an easement therein for the use of
7 public utilities, and may reserve an easement in other cases.

8 Sec. 227a. (1) Title to any part of the plat vacated by 9 the court's judgment, other than a street or alley, shall vest in 10 the rightful proprietor of that part. Title to a street or alley 11 the full width of which is vacated by the court's judgment shall 12 vest in the rightful proprietors of the lots, within the subdivi-13 sion covered by the plat, abutting the street or alley. TITLE TO 14 A PUBLIC HIGHWAY OR PORTION OF A PUBLIC HIGHWAY THAT BORDERS ON 15 OR IS ADJACENT TO A LAKE OR THE GENERAL COURSE OF A STREAM SHALL 16 VEST IN THE STATE SUBJECT TO SECTION 226.

(2) If the lots abutting the vacated street or alley on both sides belong to the same proprietor, title to the vacated street or alley shall vest in that proprietor. If the lots on opposite sides of the vacated street or alley belong to different propriteors, title up to the center line of the vacated street or alley shall vest in the respective proprietors of the abutting lots on account of the side.

(3) If only part of the width of a street or alley, not
25 extending beyond the center line, is vacated, title to the
26 vacated part of the street or alley shall vest in the proprietor
27 of the lots abutting the same.

(4) When title to any part of a vacated street or alley
 vests in an abutting proprietor, any future legal description of
 the abutting lot or lots shall include that part of the vacated
 street or alley.
