

SENATE BILL No. 767

July 21, 1993, Introduced by Senators FAXON, POLLACK, SCHWARZ and MC MANUS and referred to the Committee on Commerce.

A bill to amend Act No. 218 of the Public Acts of 1956, entitled as amended

"The insurance code of 1956,"

as amended, being sections 500.100 to 500.8302 of the Michigan Compiled Laws, by adding section 3406f.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 218 of the Public Acts of 1956, as
- 2 amended, being sections 500.100 to 500.8302 of the Michigan
- 3 Compiled Laws, is amended by adding section 3406f to read as
- 4 follows:
- 5 SEC. 3406F. (1) AS USED IN THIS SECTION, "CHILD HEALTH
- 6 SUPERVISION SERVICES" MEANS THE PERIODIC REVIEW OF A CHILD'S
- 7 PHYSICAL AND EMOTIONAL STATUS BY A PHYSICIAN OR PURSUANT TO A
- 8 PHYSICIAN'S SUPERVISION. A REVIEW SHALL INCLUDE A HISTORY,
- 9 COMPLETE PHYSICAL EXAMINATION, DEVELOPMENTAL ASSESSMENT,

- 1 ANTICIPATORY GUIDANCE, APPROPRIATE IMMUNIZATIONS, AND LABORATORY
- 2 TESTS IN KEEPING WITH PREVAILING MEDICAL STANDARDS.
- 3 (2) EFFECTIVE JANUARY 1, 1995, AN INSURER THAT DELIVERS,
- 4 ISSUES FOR DELIVERY, OR RENEWS IN THIS STATE AN EXPENSE-INCURRED
- 5 HOSPITAL, MEDICAL, OR SURGICAL POLICY OR CERTIFICATE THAT OFFERS
- 6 DEPENDENT COVERAGE SHALL PROVIDE THAT THE DEPENDENT COVERAGE
- 7 APPLICABLE TO CHILDREN INCLUDE COVERAGE FOR CHILD HEALTH SUPERVI-
- 8 SION SERVICES FROM THE MOMENT OF BIRTH THROUGH THE AGE OF 21.
- 9 EACH SUCH POLICY OR CERTIFICATE SHALL PROVIDE COVERAGE, AT A MIN-
- 10 IMUM, FOR CHILD HEALTH SUPERVISION SERVICES AT APPROXIMATELY THE
- 11 FOLLOWING AGE INTERVALS: BIRTH, 2 MONTHS, 4 MONTHS, 6 MONTHS,
- 12 9 MONTHS, 12 MONTHS, 15 MONTHS, 18 MONTHS, 2 YEARS, 3 YEARS,
- 13 4 YEARS, 5 YEARS, 6 YEARS, 8 YEARS, 10 YEARS, 12 YEARS, 14 YEARS,
- 14 16 YEARS, 18 YEARS, AND 20 YEARS. A POLICY OR CERTIFICATE MAY
- 15 PROVIDE THAT CHILD HEALTH SUPERVISION SERVICES THAT ARE RENDERED
- 16 DURING A PERIODIC REVIEW SHALL ONLY BE COVERED TO THE EXTENT THAT
- 17 THOSE SERVICES ARE PROVIDED BY OR UNDER THE SUPERVISION OF A
- 18 SINGLE PHYSICIAN DURING THE COURSE OF 1 VISIT.
- 19 (3) COVERAGE FOR CHILD HEALTH SUPERVISION SERVICES SHALL BE
- 20 EXEMPT FROM ANY COPAYMENT, COINSURANCE, DEDUCTIBLE, OR DOLLAR
- 21 LIMIT PROVISIONS IN THE POLICY OR CERTIFICATE, AND SUCH EXEMPTION
- 22 SHALL BE EXPLICITLY PROVIDED FOR IN THE POLICY OR CERTIFICATE.
