A bill to amend Act No. 218 of the Public Acts of 1956, entitled as amended

"The insurance code of 1956,"

as amended, being sections 500.100 to 500.8302 of the Michigan Compiled Laws, by adding section 3406f.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 218 of the Public Acts of 1956, as
- 2 amended, being sections 500.100 to 500.8302 of the Michigan
- 3 Compiled Laws, is amended by adding section 3406f to read as
- 4 follows:
- 5 SEC. 3406F. (1) AN INSURER THAT DELIVERS, ISSUES FOR DELIV-
- 6 ERY, OR RENEWS IN THIS STATE AN EXPENSE-INCURRED HOSPITAL, MEDI-
- 7 CAL, OR SURGICAL POLICY OR CERTIFICATE SHALL OFFER TO PROVIDE
- 8 COVERAGE TO AN INSURED FOR THE INSURED'S CHILD UNDER THE
- 9 INSURED'S POLICY OR CERTIFICATE UNTIL DECEMBER 31 OF THE CALENDAR

- 1 YEAR IN WHICH THE CHILD BECOMES 2! YEARS OF AGE IF ALL OF THE

- (A) THE CHILD IS A CHILD BY BIRTH OR ADOPTION OF THE

- (B) THE CHILD IS CONSIDERED A DEPENDENT UNDER SECTION 152 OF 5

- (2) AN INSURER THAT DELIVERS, ISSUES FOR DELIVERY, OR RENEWS

- 10 POLICY OR CERTIFICATE SHALL OFFER TO PROVIDE COVERAGE TO AN

- 12 CERTIFICATE UNTIL DECEMBER 31 OF THE CALENDAR YEAR IN WHICH THE
- 13 CHILD BECOMES 25 YEARS OF AGE IF ALL OF THE FOLLOWING ARE MET:
- (A) THE CHILD IS A CHILD BY BIRTH OR ADOPTION OF THE
- 15 INSURED.
- (B) THE CHILD IS CONSIDERED A DEPENDENT UNDER SECTION 152 OF 16
- 17 THE INTERNAL REVENUE CODE OF 1986, 26 U.S.C. 152.
- 18 (C) THE CHILD IS ENROLLED AS A FULL-TIME OR PART-TIME STU-
- 19 DENT IN AN EDUCATIONAL OR VOCATIONAL TRAINING PROGRAM.
- 20 (D) THE CHILD IS UNMARRIED.
