

HOUSE BILL No. 4195

January 30, 1995, Introduced by Rep. Ciaramitaro and referred to the Committee on Judiciary and Civil Rights.

A bill to amend section 1 of Act No. 205 of the Public Acts of 1956, entitled

"The paternity act,"

as amended by Act No. 107 of the Public Acts of 1986, being section 722.711 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 4 as follows:
- 5 Sec. 1. As used in this act:
- 6 (a) "Child born out of wedlock" means -a ANY OF THE
- 7 FOLLOWING:
- 8 (i) A child begotten and born to a woman who was not married
- 9 from the conception to the date of birth of the child. , or a

- 1 (ii) A child -which WHOM the court has determined to be a 2 child born or conceived during a marriage but not the issue of 3 that marriage.
- (iii) A CHILD BORN TO A WOMAN WHO WAS MARRIED AT THE CHILD'S
- 5 CONCEPTION OR BIRTH, AND WHO IS NO LONGER MARRIED TO A MAN TO
- 6 WHOM SHE WAS MARRIED AT THE CHILD'S CONCEPTION OR BIRTH, UNLESS A
- 7 COURT ORDER IS IN EFFECT DIRECTING THAT MAN TO PAY CHILD SUPPORT
- 8 FOR THAT CHILD.
- (b) "Child" means a child born out of wedlock.
- (c) "Mother" means the mother of a child born out of 10
- II wedlock.
- (d) "Court" means the circuit court.
