- 7 OR SEEKING LICENSURE TO OPERATE A NATURAL HAIR CULTURE SALON OR
- 8 SCHOOL OF NATURAL HAIR CULTIVATION OR SEEKING A STUDENT
- 9 REGISTRATION OR SEEKING A PERMIT TO CONDUCT AN APPRENTICESHIP
