A bill to amend Act No. 328 of the Public Acts of 1931,

entitled as amended

"The Michigan penal code,"

as amended, being sections 750.1 to 750.568 of the Michigan Compiled Laws, by adding section 502d.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Section 1. Act No. 328 of the Public Acts of 1931, as
 amended, being sections 750.1 to 750.568 of the Michigan Compiled
 Laws, is amended by adding section 502d to read as follows:
 SEC. 502D. (1) A PERSON WHO MANUFACTURES OR DISTRIBUTES IN
 THIS STATE OR CAUSES TO BE MANUFACTURED OR DISTRIBUTED IN THIS
 STATE A PRODUCT OR DEVICE THAT HE OR SHE KNOWS IS A DANGEROUSLY
 DEFECTIVE PRODUCT OR DEVICE IS GUILTY OF A CRIME PUNISHABLE AS
 PROVIDED IN SUBSECTION (3).

1 (2) A PERSON WHO MANUFACTURES OR DISTRIBUTES IN THIS STATE 2 OR CAUSES TO BE MANUFACTURED OR DISTRIBUTED IN THIS STATE A 3 PRODUCT OR DEVICE, AND WHO, AFTER MANUFACTURING OR DISTRIBUTING 4 THAT PRODUCT OR DEVICE, DISCOVERS THE PRODUCT OR DEVICE IS A DAN-5 GEROUSLY DEFECTIVE PRODUCT OR DEVICE, AND WHO FAILS TO IMMEDI-6 ATELY RECALL THE PRODUCT OR DEVICE IS GUILTY OF A CRIME PUNISH-7 ABLE AS PROVIDED IN SUBSECTION (3).

8 (3) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A FELONY 9 PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 5 YEARS OR A FINE OF 10 NOT MORE THAN \$1,000,000.00, OR BOTH.

11 (4) AS USED IN THIS SECTION:

(A) "DANGEROUSLY DEFECTIVE PRODUCT OR DEVICE" MEANS A PRODI3 UCT OR DEVICE THAT IS DESIGNED OR CONSTRUCTED IN SUCH A MANNER AS
I4 TO BE DANGEROUS TO THE HEALTH OR SAFETY OF ANY INDIVIDUAL WHEN
I5 USED IN ANY MANNER FOR WHICH THE PRODUCT OR DEVICE IS INTENDED TO
I6 BE USED OR MAY FORSEEABLY BE USED.

17 (B) "PERSON" MEANS AN INDIVIDUAL HAVING FULL OR PARTIAL
18 AUTHORITY IN A BUSINESS TO PREVENT THE MANUFACTURE OR DISTRIBU19 TION OF A PRODUCT OR DEVICE, OR TO REQUIRE THE RECALL OF A PROD20 UCT OR DEVICE.
