A bill to amend Act No. 451 of the Public Acts of 1994, entitled

"Natural resources and environmental protection act," as amended, being sections 324.101 to 324.90101 of the Michigan Compiled Laws, by adding sections 3108a, 5503a, and 20107a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 451 of the Public Acts of 1994, as
- 2 amended, being sections 324.101 to 324.90101 of the Michigan
- 3 Compiled Laws, is amended by adding sections 3108a, 5503a, and
- 4 20107a to read as follows:
- 5 SEC. 3108A. (1) THE DEPARTMENT SHALL ERECT AND MAINTAIN OR
- 6 REQUIRE A PERSON WHO HOLDS A NATIONAL POLLUTION DISCHARGE ELIMI-
- 7 NATION SYSTEM PERMIT AUTHORIZING A DISCHARGE INTO THE WATERS OF
- 8 THE STATE TO ERECT AND MAINTAIN A SIGN THAT COMPLIES WITH
- 9 SUBSECTION (2) AND IDENTIFIES EACH SITE AT WHICH A NATIONAL

- 1 POLLUTION DISCHARGE ELIMINATION SYSTEM PERMIT AUTHORIZES A
- 2 DISCHARGE INTO THE WATERS OF THIS STATE.
- 3 (2) A SIGN REQUIRED UNDER SUBSECTION (1) SHALL BE PRINTED IN
- 4 AT LEAST 4-INCH TYPE AND SHALL BE ERECTED AT A POINT ON THE SITE
- 5 THAT IS VISIBLE TO AND ACCESSIBLE BY THE GENERAL PUBLIC OR, IF
- 6 THERE IS NO POINT ON THE SITE THAT IS VISIBLE TO AND ACCESSIBLE
- 7 BY THE GENERAL PUBLIC, THE SIGN SHALL BE LOCATED AT THE NEAREST
- 8 POINT ON THE SITE THAT IS UNDER CONTROL OF THE PERSON HOLDING THE
- 9 DISCHARGE PERMIT THAT IS VISIBLE TO AND ACCESSIBLE BY THE GENERAL

- 11 SEC. 5503A. (1) THE DEPARTMENT SHALL ERECT AND MAINTAIN, OR
- 12 REQUIRE THE OWNER OR OPERATOR OF A MAJOR EMITTING FACILITY
- 13 REQUIRED TO OBTAIN A PERMIT UNDER TITLE V OF THE CLEAN AIR ACT TO
- 14 ERECT AND MAINTAIN ON THE SITE OF THE MAJOR EMITTING FACILITY, A
- 15 SIGN THAT COMPLIES WITH SUBSECTION (2) AND IDENTIFIES EACH SOURCE
- 16 AT WHICH AIR CONTAMINANTS ARE EMITTED INTO THE AIR.
- (2) A SIGN REQUIRED UNDER SUBSECTION (1) SHALL BE PRINTED IN
- 18 AT LEAST 4-INCH TYPE AND SHALL BE ERECTED AT A POINT ON THE SITE
- 19 THAT IS VISIBLE TO AND ACCESSIBLE BY THE GENERAL PUBLIC OR, IF
- 20 THERE IS NO POINT ON THE SITE THAT IS VISIBLE TO AND ACCESSIBLE
- 21 BY THE GENERAL PUBLIC, THE SIGN SHALL BE LOCATED AT THE NEAREST
- 22 POINT TO THE MAJOR EMITTING FACILITY UNDER CONTROL OF THE PERSON
- 23 HOLDING THE FACILITY PERMIT THAT IS VISIBLE TO AND ACCESSIBLE BY

- SEC. 20107A. (1) THE DEPARTMENT SHALL ERECT AND MAINTAIN OR
- 26 REQUIRE A PERSON WHO OWNS A FACILITY TO ERECT AND MAINTAIN A SIGN

- 1 THAT COMPLIES WITH SUBSECTION (2) AND IDENTIFIES EACH FACILITY AS
 2 A SITE OF ENVIRONMENTAL CONTAMINATION.
- 3 (2) A SIGN REQUIRED UNDER SUBSECTION (1) SHALL BE PRINTED IN
- 4 AT LEAST 4-INCH TYPE AND SHALL BE ERECTED AT A POINT AT THE
- 5 FACILITY THAT IS VISIBLE TO AND ACCESSIBLE BY THE GENERAL PUBLIC
- o OR, IF THERE IS NO POINT AT THE FACILITY THAT IS VISIBLE TO AND
- 7 ACCESSIBLE BY THE GENERAL PUBLIC, THE SIGN SHALL BE LOCATED AT
- 8 THE NEAREST POINT TO THE FACILITY UNDER CONTROL OF THE OWNER OF
- 9 THE FACILITY THAT IS VISIBLE TO AND ACCESSIBLE BY THE GENERAL
- 10 PUBLIC.
