

## HOUSE BILL No. 4959

June 14, 1995, Introduced by Reps. Curtis, Harder, Baade, Clack, Freeman, Gire, Martinez, Cherry, Dobronski, Goschka, Murphy, Baird, DeMars, Parks, Jaye, LaForge, Brewer, Wetters and Pitoniak and referred to the Committee on Transportation.

A bill to amend section 809 of Act No. 300 of the Public Acts of 1949, entitled as amended
"Michigan vehicle code,"
as amended by Act No. 238 of the Public Acts of 1987, being section 257.809 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Section 809 of Act No. 300 of the Public Acts of 2 1949, as amended by Act No. 238 of the Public Acts of 1987, being
- 3 section 257.809 of the Michigan Compiled Laws, is amended to read
- 4 as follows:
- 5 Sec. 809. (1) An application for transfer of registration
- 6 from a vehicle subject to section 801(1)(a) to another vehicle
- 7 subject to that section shall be accompanied by a fee of \$8.00.
- 8 In addition to the fee of \$8.00, if the registration is
- 9 transferred from a passenger vehicle to a motor home and if the

- I registration fee for the motor home is greater than the fee paid
- ${\bf 2}$  upon registration of the vehicle from which the registration was
- 3 removed, then the difference in fee shall be paid by the
- 4 applicant. If the fee is less than that paid for the registra-
- 5 tion of the vehicle from which the plates were removed, the dif-
- 6 ference shall not be refunded. The fees required by this subsec-
- 7 tion shall be considered to include all fees or charges imposed
- 8 by this act for the transfer of registration, except those which
- 9 may be assessed by section 234.
- 10 (2) An application for a transfer of registration, other
- 11 than a transfer described in subsection (1), shall be accompanied
- 12 by a fee of \$8.00. In addition to the fee of \$8.00, if the reg-
- 13 istration plates are transferred to another vehicle, as provided
- 14 in section 233, and if the plate fee for a 12-month registration
- 15 for the vehicle to which the registration is transferred is
- 16 greater than the plate fee paid upon registration of the vehicle
- 17 from which the registration was removed, then the difference
- 18 shall be paid by the applicant for the new registration. If the
- 19 fee is less than that paid for registration of the vehicle from
- 20 which the registration was removed, the difference shall not be
- 21 refunded.
- 22 (3) AN APPLICATION FOR TRANSFER OF REGISTRATION FROM A
- 23 PARENT TO A CHILD OF THE PARENT WHO IS LESS THAN 21 YEARS OF AGE
- 24 AND WHO IS RESIDING WITH THE PARENT IS NOT SUBJECT TO THE FEE
- 25 REQUIRED BY THIS SECTION.
