

HOUSE BILL No. 5024

September 12, 1995, Introduced by Rep. Jamian and referred to the Committee on Judiciary and Civil Rights.

A bill to amend sections 303, 319, and 602a of Act No. 300 of the Public Acts of 1949, entitled as amended "Michigan vehicle code,"

sections 303 and 319 as amended by Act No. 449 of the Public Acts of 1994 and section 602a as amended by Act No. 406 of the Public Acts of 1988, being sections 257.303, 257.319, and 257.602a of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 303. (1) The secretary of state shall not issue a 2 license under this act to any of the following:
- 3 (a) A person, as an operator, who is less than 18 years of
- 4 age, except the secretary of state may issue a license to a
- 5 person who is not less than 16 years of age and who has satisfac-
- 6 torily passed a driver education course and examination given by
- 7 a public school or nonpublic school of this or another state
- 8 offering a course approved by the department of education, or an
- 9 equivalent course and examination as prescribed in section 811.
- 10 The secretary of state may issue a restricted license to a person
- II not less than 14 years of age as provided in this act. This sub-
- 12 division does not apply to a person who has held a valid driver's
- 13 license issued by another state, territory, or possession of the
- 14 United States or another sovereignty for at least 1 year immedi-
- 15 ately before application for a driver's license under this act.
- (b) A person, as a chauffeur, who is less than 18 years of

- (e) A person who has been convicted of or received a probate $_{2\ court}$ disposition for negligent homicide, manslaughter, or murder $_{3\ resulting}$ from the operation of a motor vehicle.
- (f) A person who is an habitual violator of the criminal blaws relating to operating a vehicle while impaired by or under the influence of intoxicating liquor or a controlled substance or a combination of intoxicating liquor and a controlled substance, or with an alcohol content of 0.10 grams or more per 100 millilipers of blood, per 210 liters of breath, or per 67 milliliters of urine.  17 been imposed under section 319e if the person had been licensed
 18 at the time of the violation.

Sec. 602a. (1) A driver of a motor vehicle who is given by 2 hand, voice, emergency light, or siren a visual or audible signal 3 by a police or conservation officer, acting in the lawful per-4 formance of his or her duty, directing the driver to bring his or 5 her motor vehicle to a stop -, and who SHALL NOT willfully 6 -fails FAIL to obey that direction by increasing the speed of 7 the motor vehicle, extinguishing the lights of the motor vehicle, 8 or otherwise attempting to flee or elude the officer. , is g quilty of a misdemeanor, and shall be punished by imprisonment 10 for not less than 30 days nor more than 1 year, and, in addition, 11 may be fined not more than \$1,000.00 and may be ordered to pay 12 the costs of the prosecution. The court may depart from the min 13 imum term of imprisonment authorized under this subsection if the 14 court finds on the record that there are substantial and compel 15 ling reasons to do so and if the court imposes community service 16 as a part of the sentence.
