A bill to amend Act No. 368 of the Public Acts of 1978, entitled as amended

"Public health code,"

as amended, being sections 333.1101 to 333.25211 of the Michigan Compiled Laws, by adding part 94.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 368 of the Public Acts of 1978, as
- 2 amended, being sections 333.1101 to 333.25211 of the Michigan
- 3 Compiled Laws, is amended by adding part 94 to read as follows:
- 4 PART 94. OSTEOPOROSIS EDUCATION
- 5 SEC. 9401. THIS PART SHALL BE KNOWN AND MAY BE CITED AS THE
- 6 "OSTEOPOROSIS PREVENTION AND TREATMENT EDUCATION ACT".
- 7 SEC. 9403. THE DEPARTMENT MAY DO ALL OF THE FOLLOWING:

- 1 (A) ADD SUFFICIENT QUALIFIED STAFF TO IMPLEMENT THE
- 2 OSTEOPOROSIS PREVENTION AND TREATMENT EDUCATION PROGRAM
- 3 ESTABLISHED BY SECTION 9405.
- 4 (B) PROVIDE APPROPRIATE TRAINING FOR STAFF OF THE OSTEOPO-
- 5 ROSIS PREVENTION AND TREATMENT EDUCATION PROGRAM.
- 6 (C) WORK TO IMPROVE THE CAPACITY OF COMMUNITY-BASED SERVICES
- 7 AVAILABLE TO OSTEOPOROSIS PATIENTS.
- 8 (D) WORK WITH OTHER STATE AND LOCAL GOVERNMENTAL OFFICES,
- 9 COMMUNITY AND BUSINESS LEADERS, COMMUNITY ORGANIZATIONS, HEALTH
- 10 CARE AND HUMAN SERVICE PROVIDERS, AND MATICNAL OSTEOPOROSIS
- 11 ORGANIZATIONS TO COORDINATE EFFORTS AND MAXIMIZE STATE RESOURCES
- 12 IN THE AREAS OF PREVENTION, EDUCATION, AND TREATMENT OF
- 13 OSTEOPOROSIS.
- 14 (E) IDENTIFY AND, WHEN APPROPRIATE, REPLICATE OR USE SUC-
- 15 CESSFUL OSTEOPOROSIS PROGRAMS AND PROCURE RELATED MATERIALS AND
- 16 SERVICES FROM ORGANIZATIONS WITH APPROPRIATE EXPERTISE AND KNOWL-
- 17 EDGE OF OSTEOPOROSIS.
- 18 SEC. 9405. (1) THE DEPARTMENT MAY ESTABLISH AN OSTEOPOROSIS
- 19 PREVENTION AND TREATMENT EDUCATION PROGRAM.
- 20 (2) AS PART OF THE PROGRAM ESTABLISHED UNDER SUBSECTION (1),
- 21 THE DEPARTMENT MAY DESIGN AND IMPLEMENT STRATEGIES FOR RAISING
- 22 PUBLIC AWARENESS ON THE CAUSES AND NATURE OF OSTEOPOROSIS, PER-
- 23 SONAL RISK FACTORS, VALUE OF PREVENTION AND EARLY DETECTION, AND
- 24 OPTIONS FOR DIAGNOSING AND TREATING OSTEOPOROSIS.
- 25 (3) AS PART OF THE PROGRAM ESTABLISHED UNDER SUBSECTION (+),
- 26 THE DEPARTMENT MAY DEVELOP AND WORK WITH OTHER STATE AND LOCAL
- 27 AGENCIES IN PRESENTING EDUCATIONAL PROGRAMS FOR PHYSICIANS AND

- 1 OTHER HEALTH PROFESSIONALS IN THE MOST UP-TO-DATE, ACCURATE
- 2 SCIENTIFIC AND MEDICAL INFORMATION ON OSTEOPOROSIS PREVENTION,
- 3 DIAGNOSIS AND TREATMENT, THERAPEUTIC DECISION-MAKING, INCLUDING
- 4 GUIDELINES FOR DETECTING AND TREATING THE DISEASE IN SPECIAL POP-
- 5 ULATIONS, RISKS AND BENEFITS OF MEDICATIONS, AND RESEARCH
- 6 ADVANCES.
- 7 (4) AS PART OF THE PROGRAM ESTABLISHED UNDER SUBSECTION (1),
- 8 THE DEPARTMENT MAY CONDUCT A STATEWIDE NEEDS ASSESSMENT TO IDEN-
- 9 TIFY 1 OR MORE OF THE FOLLOWING:
- 10 'A' AVAILABLE TECHNICAL ASSISTANCE AND EDUCATIONAL MATERIALS
- 11 AND PROGRAMS NATIONWIDE.
- 12 (B) THE LEVEL OF PUBLIC AND PROFESSIONAL AWARENESS ABOUT
- 13 OSTEOPOROSIS.
- 14 (C) THE NEEDS OF OSTEOPOROSIS PATIENTS AND OF THEIR FAMILIES
- 15 AND CAREGIVERS.
- 16 (D) NEEDS OF HEALTH CARE PROVIDERS.
- 17 (E) THE SERVICES AVAILABLE TO OSTEOPOROSIS PATIENTS.
- 18 (F) EXISTENCE OF OSTEOPOROSIS TREATMENT PROGRAMS.
- 19 (G) EXISTENCE OF OSTEOPOROSIS SUPPORT GROUPS.
- 20 (H) EXISTENCE OF OSTEOPOROSIS REHABILITATION SERVICES.
- 21 (I) NUMBER AND LOCATION OF BONE DENSITY TESTING EQUIPMENT.
- 22 (5) BASED ON THE NEEDS ASSESSMENT CONDUCTED UNDER SUBSECTION
- 23 (4), THE DEPARTMENT MAY DEVELOP, MAINTAIN, AND MAKE AVAILABLE A
- 24 LIST OF OSTEOPOROSIS-RELATED SERVICES AND OSTEOPOROSIS HEALTH
- 25 CARE PROVIDERS WITH SPECIALIZATION IN SERVICES TO PREVENT, DIAG-
- 26 NOSE, AND TREAT OSTEOPOROSIS.

- 1 SEC. 9407. (1) THE DEPARTMENT MAY ACCEPT FROM THE STATE AND
- 2 FEDERAL GOVERNMENTS AND OTHER PUBLIC AND PRIVATE ENTITIES
- 3 SERVICES AND PROPERTY AND FUNDS FOR DEPOSIT INTO THE OSTEOPOROSIS
- 4 EDUCATION FUND CREATED IN SECTION 9409.
- 5 (2) THE DEPARTMENT SHALL SEEK A FEDERAL WAIVER OR WAIVERS
- 6 NECESSARY TO MAXIMIZE FUNDS FROM THE FEDERAL GOVERNMENT TO IMPLE-
- 7 MENT THE OSTEOPOROSIS PREVENTION AND TREATMENT EDUCATION PROGRAM.
