

HOUSE BILL No. 5128

September 26, 1995, Introduced by Reps. Bobier, Green, Gagliardi, Bodem, Lowe, Gernaat, Gnodtke, McManus, Tesanovich, Prusi and Anthony and referred to the Committee on Conservation, Environment and Great Lakes.

A bill to amend section 82113 of Act No. 451 of the Public Acts of 1994, entitled

"Natural resources and environmental protection act," as added by Act No. 58 of the Public Acts of 1995, being section 324.82113 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Section 82113 of Act No. 451 of the Public Acts
- 2 of 1994, as added by Act No. 58 of the Public Acts of 1995, being
- 3 section 324.82113 of the Michigan Compiled Laws, is amended to
- 4 read as follows:
- 5 Sec. 82113. (1) The owner of a snowmobile having been
- 6 issued a certificate of registration for the snowmobile shall
- 7 PAINT ON OR attach in a permanent manner to each side of the
- 8 forward half of the snowmobile the registration -decal NUMBER
- 9 assigned to that snowmobile IN BLOCK CHARACTERS OF GOOD

- 1 PROPORTION, NOT LESS THAN 3 INCHES IN HEIGHT, READING FROM LEFT
- 2 TO RIGHT. THE NUMBERS SHALL CONTRAST SO AS TO BE DISTINCTLY VIS-
- 3 IBLE AND LEGIBLE. A NUMBER OTHER THAN THE NUMBER AWARDED TO THE
- 4 SNOWMOBILE ON THE REGISTRATION CERTIFICATE, OR GRANTED RECIPROC-
- 5 ITY UNDER THIS PART, SHALL NOT BE ATTACHED OR OTHERWISE DISPLAYED
- 6 ON THE SNOWMOBILE.
- 7 (2) Not earlier than 90 days before the expiration date of a
- 8 certificate, a registration decal or other device may be issued
- 9 indicating that the certificate of registration is in full force
- 10 and effect.
- (3) A certificate of registration shall expire pursuant to
- 12 section 82105.
- 13 (4) The department of state may award a certificate of
- 14 number directly or may authorize a person to act as its agent for
- 15 the awarding of a certificate of number.
- 16 (5) Records of the department of state made or kept pursuant
- 17 to this part shall be made available to the public in compliance
- 18 with the freedom of information act, Act No. 442 of the Public
- 19 Acts of 1976, being sections 15.231 to 15.246 of the Michigan
- 20 Compiled Laws.
