

HOUSE BILL No. 5272

October 19, 1995, Introduced by Rep. Rhead and referred to the Committee on Appropriations.

A bill to amend section 2 of Act No. 156 of the Public Acts of 1967, entitled

"Optional retirement act of 1967,"

as amended by Act No. 296 of the Public Acts of 1994, being section 38.382 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Section 2 of Act No. 156 of the Public Acts of
- 2 1967, as amended by Act No. 296 of the Public Acts of 1994, being
- 3 section 38.382 of the Michigan Compiled Laws, is amended to read
- 4 as follows:
- 5 Sec. 2. As used in this act:
- (a) "Optional retirement program" means a system of retire-
- 7 ment benefits established as a part of the plan of compensation
- 8 for eligible teaching and administrative personnel.

- (b) "Retirement system" means the Michigan public school
- 2 employees' retirement system created by the public school
- 3 employees retirement act of 1979, Act No. 300 of the Public Acts
- 4 of 1980, being sections 38.1301 to 38.1408 of the Michigan
- 5 Compiled Laws.
- 6 (c) -"Eligible employees" EXCEPT AS OTHERWISE PROVIDED IN
- 7 THIS SUBDIVISION, "ELIGIBLE EMPLOYEE" means the members A
- 8 MEMBER of the faculty -and- OR administrative staff of A state
- 9 supported -institutions- INSTITUTION of higher education on a
- 10 full-time basis whose -positions require POSITION REQUIRES the
- 11 performance of professional services in the discharge of the edu-
- 12 cational or administrative functions of the institution.
- 13 ELIGIBLE EMPLOYEE DOES NOT INCLUDE A PERSON WHO FIRST BECOMES
- 14 EMPLOYED BY A STATE SUPPORTED INSTITUTION OF HIGHER EDUCATION
- 15 DESCRIBED IN SUBDIVISION (D)(i) TO (vii) ON OR AFTER JANUARY 1,
- 16 1996.
- (d) "State supported institution of higher education" means
- 18 any of the following:
- (i) Western Michigan university.
- 20 (ii) Eastern Michigan university.
- 21 (iii) Northern Michigan university.
- 22 (iv) Central Michigan university.
- (v) Michigan technological university.
- 24 (vi) Ferris state university.
- 25 (vii) Lake Superior state university.
- 26 (viii) A community or junior college established pursuant to
- 27 section 7 of article VIII of the state constitution of 1963.

- (ix) A community or junior college established pursuant to 2 part 25 of the school code of 1976, Act No. 451 of the Public 3 Acts of 1976, being sections 380.1601 to 380.1607 of the Michigan 4 Compiled Laws.
- (e) "Board of control" means the board charged with policy direction of a state supported institution of higher education.
- Section 2. This amendatory act shall not take effect unless 8 House Bill No. 4047 of the 88th Legislature is enacted into law.
