

HOUSE BILL No. 5286

October 25, 1995, Introduced by Rep. Sikkema and referred to the Committee on Conservation, Environment and Great Lakes.

A bill to amend section 21 of Act No. 359 of the Public Acts of 1947, entitled

"The charter township act,"

as amended by Act No. 13 of the Public Acts of 1994, being section 42.21 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 21 of Act No. 359 of the Public Acts of
- 2 1947, as amended by Act No. 13 of the Public Acts of 1994, being
- 3 section 42.21 of the Michigan Compiled Laws, is amended to read
- 4 as follows:
- 5 Sec. 21. (1) The township board shall provide in each
- 6 ordinance a sanction for violation of the ordinance.
- 7 (2) Consistent with any of the following statutes, the
- 8 township board may adopt an ordinance that designates a violation

- 2 for that violation:

- 10 (3) Consistent with the marine safety act, Act No. 303 of

- 14 law civil infraction and provides a civil fine for that
- 15 violation. This subsection does not apply unless House Bill
- 16 No. 4639 of the 87th Legislature is enacted into law.
- 17 (3) -(4) The township board may adopt an ordinance that
- 18 designates a violation of the ordinance as a municipal civil
- 19 infraction and provides a civil fine for that violation. An
- 20 ordinance may not designate a violation as a municipal civil
- 21 infraction if that violation may be designated as a civil infrac-
- 22 tion under subsection (2). or as a marine law civil infraction
- 23 under subsection (3). A statute may provide that a violation of
- 24 a specific type of ordinance is a municipal civil infraction
- 25 whether or not the ordinance designates the violation as a munic-
- 26 ipal civil infraction.

- (4) (5) An ordinance shall not make an act or omission a municipal civil infraction if that act or omission constitutes a crime under any of the following:
- (a) Article 7 or section 17766a of the public health code, 5 Act No. 368 of the Public Acts of 1978, being sections 333.7101 to 333.7545 and 333.17766a of the Michigan Compiled Laws.
- 7 (b) The Michigan penal code, Act No. 328 of the Public Acts 8 of 1931, being sections 750.1 to 750.568 of the Michigan Compiled 9 Laws.
- (c) The Michigan vehicle code, Act No. 300 of the Public 11 Acts of 1949, being sections 257.1 to 257.923 of the Michigan 12 Compiled Laws.
- (d) The Michigan liquor control act, Act No. 8 of the Public 14 Acts of the Extra Session of 1933, being sections 436.1 to 436.58 15 of the Michigan Compiled Laws.
- (e) The marine safety act, Act No. 303 of the Public Acts
 17 of 1967, being sections 281.1001 to 281.1199 PART 801 (MARINE
 18 SAFETY) OF THE NATURAL RESOURCES AND ENVIRONMENTAL PROTECTION

- 9 (j) Any law of this state under which the act or omission is
- 10 punishable by imprisonment for more than 90 days.
- 11 (5) -(6) For an ordinance not described in subsection (2)
- 12 -, OR (3), or (4), punishment for a violation of the ordinance
- 13 shall not exceed a fine of \$500.00, or imprisonment for 90 days,
- 14 or both, in the discretion of the court.
- (6) -(7) Fines collected for the violation of the ordi-
- 16 nances of a charter township shall be distributed as provided in
- 17 section 8379 of the revised judicature act of 1961, Act No. 236
- 18 of the Public Acts of 1961, being section 600.8379 of the
- 19 Michigan Compiled Laws.
