

HOUSE BILL No. 5523

January 23, 1996, Introduced by Reps. Rhead, Llewellyn, Hill, Hammerstrom, Brackenridge, Dalman and McNutt and referred to the Committee on Appropriations.

A bill to amend section 115 of Act No. 306 of the Public Acts of 1969, entitled as amended "Administrative procedures act of 1969," as amended by Act No. 83 of the Public Acts of 1993, being section 24.315 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 4 as follows:
- 5 Sec. 115. (1) Chapters 4 and 6 do not apply to proceedings
- 6 conducted under the worker's disability compensation act of 1969,
- 7 Act No. 317 of the Public Acts of 1969, as amended, being
- 8 sections 418.101 to 418.941 of the Michigan Compiled Laws.

- 9 under the provisions of enacting section 4 of that amendatory
- 10 act.
