A bill to amend Act No. 94 of the Public Acts of 1979, entitled as amended

"The state school aid act of 1979,"

as amended, being sections 388.1601 to 388.1772 of the Michigan Compiled Laws, by adding section 95a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 94 of the Public Acts of 1979, as
- 2 amended, being sections 388.1601 to 388.1772 of the Michigan
- 3 Compiled Laws, is amended by adding section 95a to read as
- 4 follows:
- 5 SEC. 95A. (1) MEMBERS OF ELECTED DISTRICT SCHOOL BOARDS ARE
- 6 ENCOURAGED TO PARTICIPATE IN PROFESSIONAL DEVELOPMENT PROGRAMS IN
- 7 EDUCATION AND LEADERSHIP AND MANAGEMENT THAT ARE DESIGNED
- 8 SPECIFICALLY FOR SCHOOL BOARD MEMBERS. IF A DISTRICT WITH A
- 9 SCHOOL BOARD PROVIDES EVIDENCE SATISFACTORY TO THE DEPARTMENT

- 1 DEMONSTRATING THAT ALL NEW SCHOOL BOARD MEMBERS HAVE PARTICIPATED
- 2 IN THIS TYPE OF PROFESSIONAL DEVELOPMENT WITHIN 1 YEAR OF TAKING
- 3 OFFICE, THERE IS ALLOCATED TO THE DISTRICT FOR THE FISCAL YEAR IN
- 4 WHICH THAT EVIDENCE IS PROVIDED AN AMOUNT PER PARTICIPATING NEW
- 5 SCHOOL BOARD MEMBER EQUAL TO 50% OF THE STATE BASIC FOUNDATION
- 6 ALLOWANCE FOR THE CURRENT STATE FISCAL YEAR, AS CALCULATED UNDER 7 SECTION 20(2).

- 9 FOR THE 1996-97 FISCAL YEAR AN AMOUNT NOT TO EXCEED \$5,000,000.00
