A bill to authorize the state administrative board to convey certain state owned property in the county of Branch in exchange for certain other property in the county of Branch.

## the people of the state of michigan enact:

1 Sec. 1. The state administrative board, on behalf of the 2 state, may convey to the township of Coldwater, in exchange for 3 property of approximately equal or greater value described in 4 section 2 , certain state owned property located in the county of

5 Branch and described as follows:

A parcel of land in the $\mathrm{SW} 1 / 4$ of section $10, \mathrm{~T} 6 \mathrm{~S}, \mathrm{R} 6 \mathrm{~W}$,
7 Branch County, Michigan and more particularly described as begin-

9 N $00^{\circ} 46^{\prime} 35^{\prime \prime} \mathrm{W} 851.64$ feet, on the west line of said section 10 ;
10 thence $\mathrm{N} 89^{\circ} 59^{\prime} 49^{\prime \prime} \mathrm{E} 379.40$ feet; thence $\mathrm{SO}^{\circ} 46^{\prime} 3^{\prime \prime \prime} \mathrm{E} 424.84$ feet;
11 thence $\mathrm{N} 89^{\circ} 59^{\prime} 49^{\prime \prime} \mathrm{E} 263.32$ feet; thence $500^{\circ} 46^{\prime} 3^{\prime \prime} \mathrm{E} 426.80$ feet,

1 to the south line of said section 10 ; thence $589^{\circ} 59^{\prime} 49^{\prime \prime} \mathrm{W} 642.72$
2 feet, on the south line of said section 10 to the point of begin-
3 ning, containing 10.00 acres, more or less.
4 Sec. 2. The property to be conveyed to the state in
5 exchange for the property described in section 1 is located in
6 the township of Coldwater, county of Branch, Michigan, and more 7 particularly described as follows:

8 A parcel of land in the west half of Section 10 , Town 06
9 South, Range 06 West, Branch County, Michigan, and more particu10 larly described as commencing at the West $1 / 4$ corner of said 11 Section 10 ; thence North 89 degrees 48 minutes 54 seconds East 1250.00 feet, to the point of beginning of this description; thence 13 North 00 degrees 18 minutes 46 seconds West $1,324.91$ feet, on the 14 easterly right-of-way of US-27 to the north line of the South $1 / 2$ 15 of the Northwest $1 / 4$ of said Section 10 ; thence North 89 degrees 1648 minutes 54 seconds East 518.03 feet, on said north line;

17 thence South 00 degrees 18 minutes 46 seconds East 1,472.93 feet;
18 thence South 89 degrees 29 minutes 28 seconds West 516.81 feet,
19 to the easterly right-of-way of US-27; thence North 00 degrees 46 20 minutes 35 seconds West 150.95 feet, to the point of beginning, 21 containing 17.53 acres, more or less.

22 Sec. 3. The conveyances authorized by this act shall be by 23 quitclaim deed approved by the attorney general.
