

HOUSE BILL No. 5641

February 27, 1996, Introduced by Reps. Lowe, Perricone, DeLange, Bodem, Randall, Dalman and Jersevic and referred to the Committee on Tax Policy.

A bill to amend the title and section 3 of Act No. 125 of the Public Acts of 1966, entitled as amended

"An act to require mortgagees and their agents to furnish annual statements to mortgagors; to require mortgagees, vendors of land contracts, and their agents to make certain adjustments to escrow accounts; and to prescribe certain rights and duties,"

being section 565.163 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. The title and section 3 of Act No. 125 of the
- 2 Public Acts of 1966, being section 565.163 of the Michigan
- 3 Compiled Laws, are amended to read as follows:
- 4 TITLE
- 5 An act to require mortgagees and their agents to furnish

- 1 to escrow accounts; and to prescribe certain rights and duties;
- 2 AND TO PROVIDE REMEDIES.
- 3 Sec. 3. (1) If , pursuant to an agreement, a mortgagor
- 4 has paid sufficient funds into an escrow account MAINTAINED BY
- 5 THE MORTGAGEE for the purpose of paying THE PROPERTY taxes on THE
- 6 mortgaged real property, -and if the mortgagee or his agent has
- 7 not paid those property taxes, then the person to whom the mort
- 8 gagor paid the funds shall be liable to the mortgagor for any
- 9 penalties or fees incurred by the mortgagor as a result of that
- 10 failure to pay taxes THE MORTGAGEE SHALL PAY THE PROPERTY TAXES
- 11 NO LATER THAN THE DATE THE TAXES ARE DUE OR DECEMBER 31 OF THE
- 12 YEAR IN WHICH THE TAXES ARE DUE, WHICHEVER OCCURS FIRST.
- 13 (2) NO LATER THAN 7 DAYS FROM THE DATE THE MORTGAGEE
- 14 RECEIVES THE TAX STATEMENT, THE MORTGAGEE SHALL PROVIDE THE MORT-
- 15 GAGOR WITH A COPY OF THE TAX STATEMENT AND DO 1 OF THE
- 16 FOLLOWING:
- 17 (A) IF SUFFICIENT FUNDS ARE AVAILABLE WITHIN THE ESCROW
- 18 ACCOUNT, NOTIFY THE MORTGAGOR OF THE DATE BY WHICH THE TAXES WILL
- 19 BE PAID.
- 20 (B) IF SUFFICIENT FUNDS ARE NOT AVAILABLE WITHIN THE ESCROW
- 21 ACCOUNT TO PAY THE TAXES, NOTIFY THE MORTGAGOR OF THE AMOUNT OF
- 22 SHORTAGE.
- 23 (3) A MORTGAGEE WHO VIOLATES THIS SECTION IS LIABLE TO THE
- 24 MORTGAGOR FOR ANY PENALTIES, FEES, OR OTHER DAMAGES INCURRED BY
- 25 THE MORTGAGOR AS A RESULT OF THE VIOLATION.
