- 7 RENEWS IN THIS STATE AN EXPENSE-INCURRED HOSPITAL, MEDICAL, OR
- 8 SURGICAL POLICY OR CERTIFICATE THAT PROVIDES MATERNITY BENEFITS
- 9 SHALL PROVIDE COVERAGE FOR A MINIMUM OF 48 HOURS OF IN-PATIENT

- 24 (A) THE FIRST MAILING TO THE INSURED AFTER THE EFFECTIVE
- 25 DATE OF THIS SECTION.
- 26 (B) JANUARY 1, 1997.
