THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Section 1. Act No. 73 of the Public Acts of 1988, as
 amended, being sections 803.221 to 803.228 of the Michigan
 Compiled Laws, is amended by adding section 5a to read as
 follows:

SEC. 5A. THE DEPARTMENT SHALL ENSURE THAT A JUVENILE WHO IS
COMMITTED TO A JUVENILE FACILITY FOR A VIOLATION OR AN ATTEMPTED
VIOLATION OF SECTION 520B, 520C, 520D, 520E, OR 520G OF THE
MICHIGAN PENAL CODE, ACT NO. 328 OF THE PUBLIC ACTS OF 1931,
BEING SECTIONS 750.520B, 750.520C, 750.520D, 750.520E, AND

1 750.520G OF THE MICHIGAN COMPILED LAWS, HAS PROVIDED BLOOD 2 SAMPLES FOR CHEMICAL TESTING FOR DNA IDENTIFICATION PROFILING OR 3 A DETERMINATION OF THE BLOOD'S GENETIC MARKERS AND HAS PROVIDED 4 SAMPLES OF HIS OR HER SALIVA FOR CHEMICAL TESTING TO DETERMINE 5 THE SECRETOR STATUS OF THE SALIVA BEFORE THE JUVENILE IS RELEASED 6 FROM THAT JUVENILE FACILITY. HOWEVER, IF AT THE TIME THE JUVE-7 NILE IS TO BE RELEASED THE DEPARTMENT OF STATE POLICE ALREADY HAS 8 A SAMPLE OF THE JUVENILE'S BLOOD OR SALIVA THAT MEETS THE 9 REQUIREMENTS OF THE RULES PROMULGATED UNDER THE DNA IDENTIFICA-10 TION PROFILING SYSTEM ACT, ACT NO. 250 OF THE PUBLIC ACTS OF 11 1990, BEING SECTIONS 28.171 TO 28.176 OF THE MICHIGAN COMPILED 12 LAWS, THE JUVENILE IS NOT REQUIRED TO PROVIDE ANOTHER SAMPLE OF 13 THE SAME BODY FLUID. THE BLOOD OR SALIVA SAMPLES REQUIRED TO BE 14 COLLECTED UNDER THIS SECTION SHALL BE COLLECTED BY THE DEPARTMENT 15 AND TRANSMITTED BY THE DEPARTMENT TO THE DEPARTMENT OF STATE 16 POLICE IN THE MANNER PRESCRIBED BY RULES PROMULGATED UNDER THE 17 DNA IDENTIFICATION PROFILING SYSTEM ACT, ACT NO. 250 OF THE 18 PUBLIC ACTS OF 1990.

Section 2. This amendatory act shall not take effect unless
Senate Bill No. ____ or House Bill No. 5783 (request no. 05773'95)
of the 88th Legislature is enacted into law.
