

## HOUSE BILL No. 5981

July 2, 1996, Introduced by Rep. Fitzgerald and referred to the Committee on Judiciary and Civil Rights.

A bill to amend section 243e of Act No. 328 of the Public Acts of 1931, entitled as amended
"The Michigan penal code,"

being section 750.243e of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 243e of Act No. 328 of the Public Acts
- 2 of 1931, being section 750.243e of the Michigan Compiled Laws, is
- 3 amended to read as follows:
- 4 Sec. 243e. (1) Any EXCEPT AS PROVIDED IN SUBSECTION (2),
- 5 A person , firm, copartnership or corporation, who violates
- 6 any of the provisions of sections 243a to 243d SECTION 243A,
- 7 243B, 243C, OR 243D, or who violates the terms of any A permit
- 8 issued thereunder UNDER SECTION 243A, 243B, 243C, OR 243D, is
- 9 quilty of a misdemeanor PUNISHABLE BY IMPRISONMENT FOR NOT MORE
- 10 THAN 93 DAYS OR A FINE OR NOT MORE THAN \$500.00, OR BOTH.

- 1 (2) A PERSON WHO OFFERS FOR SALE, EXPOSES FOR SALE, SELLS AT
- 2 RETAIL, OR KEEPS WITH INTENT TO SELL AT RETAIL FIREWORKS IN VIO-
- 3 LATION OF SECTION 243A IS GUILTY OF A CRIME AS FOLLOWS:
- 4 (A) EXCEPT AS PROVIDED IN SUBDIVISIONS (B) AND (C), IF THE
- 5 VIOLATION INVOLVES LESS THAN 5 POUNDS OF FIREWORKS, THE PERSON IS
- 6 GUILTY OF A MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE
- 7 THAN 93 DAYS OR A FINE OF NOT MORE THAN \$500.00, OR BOTH.
- 8 (B) IF THE VIOLATION INVOLVES LESS THAN 5 POUNDS OF FIRE-
- 9 WORKS AND THE PERSON HAS 1 PRIOR CONVICTION FOR VIOLATING SECTION
- 10 243A, 243B, 243C, OR 243D OR A PERMIT ISSUED UNDER SECTION 243A,
- 11 243B, 243C, OR 243D, THE PERSON IS GUILTY OF A MISDEMEANOR PUN-
- 12 ISHABLE BY IMPRISONMENT FOR NOT MORE THAN 1 YEAR OR A FINE OF NOT
- 13 MORE THAN \$500.00, OR BOTH.
- (C) IF THE VIOLATION INVOLVES LESS THAN 5 POUNDS OF FIRE-
- 15 WORKS AND THE PERSON HAS 2 OR MORE PRIOR CONVICTIONS FOR VIOLAT-
- 16 ING SECTION 243A, 243B, 243C, OR 243D OR A PERMIT ISSUED UNDER
- 17 SECTION 243A, 243B, 243C, OR 243D, THE PERSON IS GUILTY OF A
- 18 FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 4 YEARS OR A
- 19 FINE OF NOT MORE THAN \$2,500.00, OR BOTH.
- 20 (D) EXCEPT AS PROVIDED IN SUBDIVISION (E), IF THE VIOLATION
- 21 INVOLVES 5 OR MORE POUNDS OF FIREWORKS BUT LESS THAN 25 POUNDS OF
- 22 FIREWORKS, THE PERSON IS GUILTY OF A MISDEMEANOR PUNISHABLE BY
- 23 IMPRISONMENT FOR NOT MORE THAN 1 YEAR OR A FINE OF NOT MORE THAN
- 24 \$1,000.00, OR BOTH.
- 25 (E) IF THE VIOLATION INVOLVES 5 OR MORE POUNDS OF FIREWORKS
- 26 BUT LESS THAN 25 POUNDS OF FIREWORKS AND THE PERSON HAS 1 OR MORE
- 27 PRIOR CONVICTIONS FOR VIOLATING SECTION 243A, 243B, 243C, OR 243D

- 1 OR A PERMIT ISSUED UNDER SECTION 243A, 243B, 243C, OR 243D, THE
- 2 PERSON IS GUILTY OF A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT
- 3 MORE THAN 4 YEARS OR A FINE OF NOT MORE THAN \$2,500.00, OR BOTH.
- 4 (F) IF THE VIOLATION INVOLVES 25 OR MORE POUNDS OF FIRE-
- 5 WORKS, THE PERSON IS GUILTY OF A FELONY PUNISHABLE BY IMPRISON-
- 6 MENT FOR NOT MORE THAN 4 YEARS OR A FINE OF NOT MORE THAN
- 7 \$2,500.00, OR BOTH.
- 8 (3) AS USED IN THIS SECTION, "PERSON" MEANS AN INDIVIDUAL,
- 9 PARTNERSHIP, CORPORATION, ASSOCIATION, GOVERNMENTAL ENTITY, OR
- 10 OTHER LEGAL ENTITY.
