A bill to amend Act No. 87 of the Public Acts of 1985, entitled as amended

"Crime victim's rights act,"

as amended, being sections 780.751 to 780.834 of the Michigan Compiled Laws, by adding sections 11a, 39a, and 71a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:
