

HOUSE BILL No. 6083

September 12, 1996, Introduced by Reps. Crissman, Green, Goschka, McBryde, Hammerstrom, Horton, Gernaat, Middleton, Dolan, Dobb, Rocca, Lowe, Jellema, Byl, Pitoniak, Bodem, Jamian, Yokich, Brewer, Geiger, Rhead and Voorhees and referred to the Committee on Judiciary and Civil Rights.

A bill to amend sections 2 and 4 of Act No. 60 of the Public Acts of 1962, entitled as amended

"An act to provide for the day parole of prisoners in county jails to permit them to be gainfully employed outside the jail or pursue other activities; to provide for the granting of reductions in terms of imprisonment and the regulation thereof; and to provide for the disposition of earnings from such employment,"

being sections 801.252 and 801.254 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Sections 2 and 4 of Act No. 60 of the Public
- 2 Acts of 1962, being sections 801.252 and 801.254 of the Michigan
- 3 Compiled Laws, are amended to read as follows:
- 4 Sec. 2. The sheriff, or friend of the court in alimony or
- 5 nonsupport cases, shall collect the wages or salary of an
- 6 employed prisoner, or require him OR HER to turn over his OR HER
- 7 wages or salary in full when received. The officer shall deposit

- I the -same- WAGES OR SALARY in a trust checking account and keep a
- 2 ledger showing the status of the account of each prisoner. The
- 3 wages or salary are not subject to garnishment in the hands of
- 4 the employer or the officer during the prisoner's term EXCEPT
- 5 THAT THE WAGES OR SALARY IS SUBJECT TO GARNISHMENT WHILE IN THE
- 6 HANDS OF THE SHERIFF IF THE GARNISHMENT IS FOR THE PURPOSE OF
- 7 SATISFYING AN ORDER OF A COURT OF THIS STATE TO PAY COURT COSTS
- 8 OR FEES.
- 9 Sec. 4. The sheriff or friend of the court shall disburse
- 10 the wages or salary of an employed prisoner for only the follow-
- 11 ing purposes in the FOLLOWING order: -stated:
- 12 (a) Board of the prisoner.
- (b) Necessary travel expense to and from work and other
- 14 incidental expenses of the prisoner.
- (c) Support of the prisoner's dependents, if any. ---
- (d) Payment, either in full or ratably, of the prisoner's
- 17 obligations, acknowledged by him in writing, or which have been
- 18 reduced to judgment, -- INCLUDING COMPLYING WITH GARNISHMENT FOR
- 19 THE RECOVERY OF COURT-ORDERED COSTS OR FEES AS ALLOWED UNDER SEC-
- 20 TION 2.
- 21 (e) The balance, if any, to the prisoner upon his OR HER
- 22 discharge.
