

SENATE BILL No. 10

January 17, 1995, Introduced by Senator PETERS and referred to the Committee on Health Policy and Senior Citizens.

A bill to amend Act No. 350 of the Public Acts of 1980, entitled as amended

"The nonprofit health care corporation reform act," as amended, being sections 500.1101 to 500.1704 of the Michigan Compiled Laws, by adding section 418.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 350 of the Public Acts of 1980, as
- 2 amended, being sections 500.1101 to 500.1704 of the Michigan
- 3 Compiled Laws, is amended by adding section 418 to read as
- 4 follows:
- 5 SEC. 418. (1) AS USED IN THIS SECTION, "CHILD HEALTH SUPER-
- 6 VISION SERVICES" MEANS THE PERIODIC REVIEW OF A CHILD'S PHYSICAL
- 7 AND EMOTIONAL STATUS BY A PHYSICIAN OR PURSUANT TO A PHYSICIAN'S
- 8 SUPERVISION. A REVIEW INCLUDES A HISTORY, COMPLETE PHYSICAL
- 9 EXAMINATION, DEVELOPMENTAL ASSESSMENT, ANTICIPATORY GUIDANCE,

- 1 APPROPRIATE IMMUNIZATIONS, AND LABORATORY TESTS IN KEEPING WITH
- 2 PREVAILING MEDICAL STANDARDS.
- 3 (2) EFFECTIVE JANUARY 1, 1997, A HEALTH CARE CORPORATION
- 4 GROUP OR NONGROUP CERTIFICATE THAT OFFERS DEPENDENT BENEFITS
- 5 SHALL PROVIDE THAT THE DEPENDENT BENEFITS APPLICABLE TO CHILDREN
- 6 INCLUDE BENEFITS FOR CHILD HEALTH SUPERVISION SERVICES FROM THE
- 7 MOMENT OF BIRTH THROUGH THE AGE OF 21. EACH CERTIFICATE SHALL
- 8 PROVIDE BENEFITS, AT A MINIMUM, FOR CHILD HEALTH SUPERVISION
- 9 SERVICES AT APPROXIMATELY THE FOLLOWING AGE INTERVALS: BIRTH,
- 10 2 MONTHS, 4 MONTHS, 6 MONTHS, 9 MONTHS, 12 MONTHS, 15 MONTHS,
- 11 18 MONTHS, 2 YEARS, 3 YEARS, 4 YEARS, 5 YEARS, 6 YEARS, 8 YEARS,
- 12 10 YEARS, 12 YEARS, 14 YEARS, 16 YEARS, 18 YEARS, AND 20 YEARS.
- 13 A CERTIFICATE MAY PROVIDE THAT CHILD HEALTH SUPERVISION SERVICES
- 14 THAT ARE RENDERED DURING A PERIODIC REVIEW ARE ONLY COVERED TO
- 15 THE EXTENT THAT THOSE SERVICES ARE PROVIDED BY OR UNDER THE
- 16 SUPERVISION OF A SINGLE PHYSICIAN DURING THE COURSE OF 1 VISIT.
- 17 (3) BENEFITS FOR CHILD HEALTH SUPERVISION SERVICES ARE
- 18 EXEMPT FROM ANY COPAYMENT, DEDUCTIBLE, OR DOLLAR LIMIT PROVISIONS
- 19 IN THE CERTIFICATE, AND THE EXEMPTION SHALL BE EXPLICITLY PRO-
- 20 VIDED FOR IN THE CERTIFICATE.
