

## **SENATE BILL No. 97**

January 17, 1995, Introduced by Senator BYRUM and referred to the Committee on Education.

A bill to amend Act No. 451 of the Public Acts of 1976, entitled as amended

"The school code of 1976,"

as amended, being sections 380.1 to 380.1852 of the Michigan Compiled Laws, by adding section 1165.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 451 of the Public Acts of 1976, as
- 2 amended, being sections 380.1 to 380.1852 of the Michigan
- 3 Compiled Laws, is amended by adding section 1165 to read as
- 4 follows:
- 5 SEC. 1165. (1) THE MICHIGAN STUDENTS VOTE ADVISORY COUNCIL
- 6 IS CREATED IN THE DEPARTMENT OF EDUCATION AS AN ADVISORY BODY TO
- 7 THE STATE BOARD, TO CONSIST OF THE FOLLOWING MEMBERS:
- 8 (A) ONE MEMBER APPOINTED BY THE GOVERNOR.

- 1 (B) ONE MEMBER APPOINTED BY THE SPEAKER OF THE HOUSE OF
- 2 REPRESENTATIVES.
- 3 (C) ONE MEMBER APPOINTED BY THE SENATE MAJORITY LEADER.
- 4 (D) ONE MEMBER APPOINTED BY THE STATE BOARD IF THE STATE
- 5 BOARD ELECTS TO DO SO.
- 6 (E) ONE MEMBER APPOINTED BY THE SECRETARY OF STATE IF THE
- 7 SECRETARY OF STATE ELECTS TO DO SO. A MEMBER APPOINTED UNDER
- 8 THIS SUBDIVISION IS A NONVOTING MEMBER.
- 9 (F) AT LEAST 5 ADDITIONAL MEMBERS APPOINTED BY THE MEMBERS
- 10 APPOINTED UNDER SUBDIVISIONS (A), (B), (C), AND (D). THE ADDI-
- 11 TIONAL MEMBERS SHALL BE REPRESENTATIVES OF NONPROFIT, NONGOVERN-
- 12 MENTAL ORGANIZATIONS OTHER THAN POLITICAL PARTIES OR ORGANIZA-
- 13 TIONS REGISTERED UNDER THE MICHIGAN CAMPAIGN FINANCE ACT. ACT
- 14 NO. 388 OF THE PUBLIC ACTS OF 1976, BEING SECTIONS 169.201 TO
- 15 169.282 OF THE MICHIGAN COMPILED LAWS.
- 16 (2) A VACANCY ON THE ADVISORY COUNCIL SHALL BE FILLED IN THE
- 17 SAME MANNER AS THE ORIGINAL APPOINTMENT.
- 18 (3) THE MEMBER OF THE ADVISORY COUNCIL APPOINTED BY THE
- 19 STATE BOARD SHALL SERVE AS THE CHAIRPERSON OF THE ADVISORY
- 20 COUNCIL. HOWEVER, DURING A PERIOD WHEN THERE IS NO SUCH MEMBER
- 21 SERVING, THE OTHER MEMBERS SHALL ELECT A MEMBER TO SERVE AS
- 22 CHAIRPERSON.
- 23 (4) THE ADVISORY COUNCIL SHALL DO ALL OF THE FOLLOWING:
- 24 (A) REVIEW PROGRAMS DEVELOPED BY OTHER ENTITIES RELATED TO
- 25 INSTRUCTING AND ENCOURAGING STUDENTS TO VOTE AND, USING CRITERIA
- 26 DEVELOPED BY THE ADVISORY COUNCIL AND APPROVED BY THE STATE
- 27 BOARD, MAKE RECOMMENDATIONS TO THE STATE BOARD ON THE POSSIBLE

- 1 ADOPTION OF 1 OR MORE OF THOSE PROGRAMS FOR USE AS PART OF A
- 2 MICHIGAN STUDENTS VOTE PROGRAM.
- 3 (B) RECOMMEND MODEL CURRICULA AND RELATED EDUCATIONAL MATE-
- 4 RIALS FOR A MICHIGAN STUDENTS VOTE PROGRAM INSTRUCTING PUPILS AT
- 5 VARIOUS GRADE LEVELS ON THE ELECTORAL PROCESS AND THE IMPORTANCE
- 6 OF VOTING AND ON HOW TO MARK AND CAST A BALLOT, AND REPORT TO THE
- 7 STATE BOARD ON THE MODEL CURRICULA AND RELATED EDUCATIONAL
- 8 MATERIALS. THE MODEL CURRICULA AND EDUCATIONAL MATERIALS SHALL
- 9 BE COMPATIBLE WITH THE MODEL CORE ACADEMIC CURRICULUM DEVELOPED
- 10 UNDER SECTION 1278.
- 11 (C) DEVELOP AND SUBMIT TO THE STATE BOARD CRITERIA FOR
- 12 ENSURING DIVERSITY IN THE MICHIGAN STUDENTS VOTE PROGRAM PILOT
- 13 PROJECTS DESCRIBED IN SUBSECTION (5).
- 14 (5) THE ADVISORY COUNCIL MAY DO ALL OF THE FOLLOWING:
- 15 (A) WORK WITH THE SECRETARY OF STATE AND LOCAL ELECTIONS
- 16 OFFICIALS TO DEVELOP WAYS TO CONDUCT A SIMULATED BALLOT PROGRAM
- 17 AT OFFICIAL VOTING PLACES AS PART OF A MICHIGAN STUDENTS VOTE
- 18 PROGRAM.
- 19 (B) ENGAGE IN PROMOTIONAL AND OTHER ACTIVITIES DESIGNED TO
- 20 ENCOURAGE PUPILS TO CONSIDER VOTING TO BE A DESIRABLE PRACTICE.
- 21 (6) AFTER CONSIDERING THE MODEL CURRICULA AND RELATED EDUCA-
- 22 TIONAL MATERIALS RECOMMENDED UNDER SUBSECTION (4) (B) AND ANY PRO-
- 23 GRAMS RECOMMENDED UNDER SUBSECTION (4)(A), THE STATE BOARD MAY
- 24 APPROVE 1 OR MORE PROGRAMS AS A MICHIGAN STUDENTS VOTE PROGRAM.
- 25 THE STATE BOARD MAY APPROVE OR MODIFY ANY PROGRAM RECOMMENDED BY
- 26 THE ADVISORY COUNCIL OR MAY CONSIDER AND APPROVE AS A MICHIGAN

- 1 STUDENTS VOTE PROGRAM A PROGRAM THAT WAS NOT RECOMMENDED BY THE
- 2 ADVISORY COUNCIL.
- 3 (7) TO BE APPROVED BY THE STATE BOARD, A MICHIGAN STUDENTS
- 4 VOTE PROGRAM SHALL MEET ALL OF THE FOLLOWING:
- 5 (A) SHALL PRESENT ELECTORAL ISSUES IN A NEUTRAL AND INFORMA-
- 6 TIVE MANNER THAT IS NOT LIKELY TO CREATE A BIAS FOR OR AGAINST A
- 7 POLITICAL PARTY OR A CANDIDATE OR MEASURE ON THE BALLOT.
- 8 (B) SHALL CONTAIN CLASSROOM CURRICULA THAT INCLUDE AT LEAST
- 9 INSTRUCTION IN THE ELECTORAL PROCESS AND THE IMPORTANCE OF VOTING
- 10 AND IN HOW TO MARK AND CAST A BALLOT.
- 11 (C) SHALL ALLOW A PUPIL TO CAST A SIMULATED BALLOT ON THE
- 12 REGULAR ELECTION DAY AT THE OFFICIAL VOTING PLACE ESTABLISHED FOR
- 13 REGISTERED VOTERS IN THE PUPIL'S PRECINCT OF RESIDENCE.
- 14 (D) SUBJECT TO SUBSECTION (8), SHALL INCLUDE ON THE SIMU-
- 15 LATED BALLOT ALL OF THE FOLLOWING THAT ARE ON THE OFFICIAL BALLOT
- 16 FOR A PARTICULAR ELECTION:
- 17 (i) THE OFFICES OF PRESIDENT AND VICE PRESIDENT OF THE
- 18 UNITED STATES, UNITED STATES SENATOR, UNITED STATES REPRESENTA-
- 19 TIVE, GOVERNOR AND LIEUTENANT GOVERNOR, STATE SENATOR, STATE REP-
- 20 RESENTATIVE, STATE ATTORNEY GENERAL, SECRETARY OF STATE, MEMBER
- 21 OF THE STATE BOARD, AND MEMBER OF AN ELECTED STATE UNIVERSITY
- 22 GOVERNING BOARD.
- 23 (ii) ALL STATEWIDE BALLOT PROPOSALS.
- 24 (8) A SCHOOL DISTRICT THAT IMPLEMENTS A MICHIGAN STUDENTS
- 25 VOTE PROGRAM APPROVED BY THE STATE BOARD MAY ADD OFFICES OR
- 26 BALLOT PROPOSALS TO OR DELETE BALLOT PROPOSALS FROM THE SIMULATED
- 27 BALLOT PRESCRIBED IN SUBSECTION (7)(D).

- 1 (9) BEGINNING JANUARY 1, 1996, THE STATE BOARD MAY AWARD A
- 2 GRANT TO A SCHOOL DISTRICT TO ASSIST THE SCHOOL DISTRICT TO
- 3 IMPLEMENT A STATE BOARD APPROVED MICHIGAN STUDENTS VOTE PROGRAM
- 4 AS A PILOT PROJECT. THE GRANT SHALL BE MADE FROM THE MICHIGAN
- 5 STUDENTS VOTE FUND ESTABLISHED UNDER SUBSECTION (11). TO THE
- 6 EXTENT PRACTICABLE, THE STATE BOARD SHALL ENSURE THAT GRANTS
- 7 AWARDED UNDER THIS SUBSECTION ARE MADE TO SCHOOL DISTRICTS THAT
- 8 ARE DIVERSE AS TO GEOGRAPHIC LOCATION, SIZE, POPULATION, AND
- 9 DEMOGRAPHIC CHARACTERISTICS, TAKING INTO CONSIDERATION THE CRI-
- 10 TERIA FOR DIVERSITY DEVELOPED BY THE ADVISORY COUNCIL UNDER
- 11 SUBSECTION (4)(C).
- 12 (10) A SCHOOL DISTRICT MAY ADOPT AND USE ANY MICHIGAN STU-
- 13 DENTS VOTE PROGRAM APPROVED BY THE STATE BOARD, WHETHER OR NOT
- 14 THE SCHOOL DISTRICT RECEIVES A PILOT PROJECT GRANT UNDER
- 15 SUBSECTION (9), OR MAY ADOPT, DEVELOP, OR USE ANOTHER SIMULATED
- 16 OR MOCK ELECTION CURRICULUM OR PROGRAM. HOWEVER, BEGINNING
- 17 JANUARY 1, 1996, ONLY PUPILS PARTICIPATING IN A STATE BOARD
- 18 APPROVED MICHIGAN STUDENTS VOTE PROGRAM SHALL BE ALLOWED TO CAST
- 19 A SIMULATED BALLOT ON THE ELECTION DAY AT AN OFFICIAL VOTING
- 20 PLACE. IF A SCHOOL DISTRICT ADOPTS AND USES A STATE BOARD
- 21 APPROVED MICHIGAN STUDENTS VOTE PROGRAM IN 1 OR MORE GRADE
- 22 LEVELS, THE SCHOOL DISTRICT SHALL NOT HAVE THE PARTICIPATING
- 23 PUPILS CAST A SIMULATED BALLOT ON THE ELECTION DAY AT AN OFFICIAL
- 24 VOTING PLACE UNLESS THE SCHOOL DISTRICT MAKES THE PROGRAM AVAIL-
- 25 ABLE TO ALL PUPILS IN THE SCHOOL DISTRICT IN THOSE GRADE LEVELS.
- 26 (11) THERE IS CREATED THE MICHIGAN STUDENTS VOTE FUND AS A
- 27 SEPARATE FUND IN THE STATE TREASURY, TO BE ADMINISTERED BY THE

- 1 STATE BOARD. THE STATE BOARD MAY ACCEPT MONEY FOR THE FUND FROM
- 2 ANY SOURCE AND SHALL DEPOSIT THAT MONEY WITH THE STATE TREASURER
- 3 FOR CREDIT TO THE FUND. THE FUND SHALL BE USED TO FUND GRANTS
- 4 MADE UNDER SUBSECTION (9) AND FOR FUNDING THE ACTIVITIES OF THE
- 5 MICHIGAN STUDENTS VOTE ADVISORY COUNCIL. THE STATE TREASURER
- 6 SHALL DIRECT THE INVESTMENT OF THE FUND MONEY AND SHALL CREDIT
- 7 EARNINGS TO THE FUND. MONEY IN THE FUND AT THE END OF A FISCAL
- 8 YEAR SHALL NOT REVERT TO THE GENERAL FUND BUT SHALL BE CARRIED
- 9 OVER IN THE FUND TO THE NEXT SUCCEEDING FISCAL YEAR.
- 10 Section 2. This amendatory act shall not take effect unless
- 11 Senate Bill No. 98
- 12 of the 88th Legislature is enacted into law.
