

## **SENATE BILL No. 166**

January 31, 1995, Introduced by Senator SHUGARS and referred to the Committee on Families, Mental Health and Human Services.

A bill to amend Act No. 280 of the Public Acts of 1939, entitled as amended

"The social welfare act,"

as amended, being sections 400.1 to 400.119b of the Michigan Compiled Laws, by adding section 1d.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 280 of the Public Acts of 1939, as
- 2 amended, being sections 400.1 to 400.119b of the Michigan
- 3 Compiled Laws, is amended by adding section 1d to read as
- 4 follows:
- 5 SEC. 1D. (1) EXCEPT AS PROVIDED IN SUBSECTION (2) OR (3),
- 6 THE STATE DEPARTMENT SHALL NOT EMPLOY OR APPOINT AN INDIVIDUAL TO
- 7 SERVE IN A POSITION IN THE STATE DEPARTMENT THAT REQUIRES DIRECT
- 8 INTERACTION WITH CHILDREN AND YOUTH SERVICES, INCLUDING, BUT NOT
- 9 LIMITED TO, POSITIONS DEALING WITH ABUSE, NEGLECT, DETENTION,

- 1 FOSTER CARE, ADOPTION, OR PROBATION SERVICES, IF THAT INDIVIDUAL
- 2 HAS BEEN CONVICTED OF A FELONY OR IS SUBJECT TO ANY PENDING
- 3 FELONY CHARGES AS REVEALED BY RECORDS CONTAINED IN THE STATE
- 4 REPOSITORY OF CRIMINAL HISTORY RECORD INFORMATION, WHICH THE
- 5 STATE DEPARTMENT SHALL OBTAIN THROUGH THE USE OF THE LAW ENFORCE-
- 6 MENT INFORMATION NETWORK, OR BY RECORDS OBTAINED PURSUANT TO A
- 7 NATIONAL CRIMINAL HISTORY RECORD CHECK. THE STATE DEPARTMENT
- 8 SHALL REQUIRE APPLICANTS FOR EMPLOYMENT OR APPOINTMENT TO BE FIN-
- 9 GERPRINTED AND TO EXECUTE ANY CONSENTS NECESSARY TO IMPLEMENT THE
- 10 CRIMINAL HISTORY CHECK REQUIRED UNDER THIS SUBSECTION. THE
- 11 DEPARTMENT OR AGENCY TAKING THE FINGERPRINTS SHALL SUBMIT A SET
- 12 OF THE FINGERPRINTS TO THE DEPARTMENT OF STATE POLICE, WHICH
- 13 SHALL FORWARD THEM TO THE FEDERAL BUREAU OF INVESTIGATION, OR
- 14 OTHER AGENCY DESIGNATED BY THE FEDERAL BUREAU OF INVESTIGATION,
- 15 PURSUANT TO FEDERAL LAW FOR A NATIONAL CRIMINAL HISTORY RECORD
- 16 CHECK. UPON RECEIPT OF THE REPORT OF THE FEDERAL BUREAU OF
- 17 INVESTIGATION, THE DEPARTMENT OF STATE POLICE SHALL FORWARD THE
- 18 REPORT TO THE STATE DEPARTMENT.
- 19 (2) EXCEPT AS PROVIDED IN SUBSECTION (4), THE DIRECTOR MAY
- 20 WAIVE THE PROHIBITION IN SUBSECTION (1) AS TO AN INDIVIDUAL WHO
- 21 HAS BEEN CONVICTED OF A FELONY, IF BOTH OF THE FOLLOWING CIRCUM-
- 22 STANCES EXIST:
- (A) THE DATE OF FINAL RELEASE FROM INCARCERATION, THE DATE
- 24 OF FINAL RELEASE FROM PROBATION, OR THE DATE OF FINAL RELEASE
- 25 FROM PAROLE, WHICHEVER IS LATER, OCCURRED NOT LESS THAN 5 YEARS
- 26 BEFORE THE DATE ON WHICH THE INDIVIDUAL APPLIES FOR THE

- 1 APPOINTMENT OR EMPLOYMENT, AND THE PERSON IS NOT SUBJECT TO ANY
- 2 PENDING FELONY CHARGES.
- 3 (B) THE DIRECTOR CONDUCTS AN EXTENSIVE AND COMPLETE INVESTI-
- 4 GATION OF THE INDIVIDUAL'S BACKGROUND, AND DETERMINES THAT, NOT-
- 5 WITHSTANDING THE INDIVIDUAL'S FELONY CONVICTION, THE EMPLOYMENT
- 6 OR APPOINTMENT OF THE INDIVIDUAL IS APPROPRIATE. A WRITTEN
- 7 REPORT, SIGNED BY THE DIRECTOR, SHALL BE MADE OF EVERY INVESTIGA-
- 8 TION UNDER THIS SUBDIVISION THAT RESULTS IN A DETERMINATION THAT
- 9 AN INDIVIDUAL'S EMPLOYMENT OR APPOINTMENT IS APPROPRIATE.
- 10 (3) THIS SECTION DOES NOT APPLY TO A PERSON EMPLOYED BY OR
- 11 APPOINTED TO A POSITION IN THE STATE DEPARTMENT PRIOR TO THE
- 12 EFFECTIVE DATE OF THIS SECTION.
- 13 (4) THE DIRECTOR SHALL NOT WAIVE THE PROHIBITION IN SUBSEC-
- 14 TION (1) AS TO AN INDIVIDUAL WHO HAS BEEN CONVICTED OF 1 OR MORE
- 15 OF THE FOLLOWING:
- 16 (A) ASSAULT WITH INTENT TO COMMIT MURDER, IN VIOLATION OF
- 17 SECTION 83 OF THE MICHIGAN PENAL CODE, ACT NO. 328 OF THE PUBLIC
- 18 ACTS OF 1931, BEING SECTION 750.83 OF THE MICHIGAN COMPILED
- 19 LAWS.
- 20 (B) ASSAULT WITH INTENT TO ROB AND STEAL, IN VIOLATION OF
- 21 SECTION 89 OF ACT NO. 328 OF THE PUBLIC ACTS OF 1931, BEING SEC-
- 22 TION 750.89 OF THE MICHIGAN COMPILED LAWS.
- 23 (C) ATTEMPTED MURDER, IN VIOLATION OF SECTION 91 OF ACT
- 24 NO. 328 OF THE PUBLIC ACTS OF 1931, BEING SECTION 750.91 OF THE
- 25 MICHIGAN COMPILED LAWS.
