



SENATE BILL No. 840

February 13, 1996, Introduced by Senators SHUGARS and SCHWARZ and referred to the Committee on Health Policy and Senior Citizens.

A bill to amend Act No. 368 of the Public Acts of 1978, entitled as amended "Public health code," as amended, being sections 333.1101 to 333.25211 of the Michigan Compiled Laws, by adding section 13407.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Act No. 368 of the Public Acts of 1978, as
2 amended, being sections 333.1101 to 333.25211 of the Michigan
3 Compiled Laws, is amended by adding section 13407 to read as
4 follows:

5 SEC. 13407. (1) BEFORE ALLOWING A MINOR WHO IS UNDER 18
6 YEARS OF AGE TO USE A TANNING DEVICE IN A TANNING FACILITY, THE
7 OWNER OR OPERATOR OF THE TANNING FACILITY SHALL REQUIRE THE
8 PRESENTMENT OF A STATEMENT SIMILAR TO THE STATEMENT REQUIRED
9 UNDER SECTION 13405(J) SIGNED BY THE MINOR'S PARENT, LEGAL

1 GUARDIAN, OR PERSON IN LOCO PARENTIS INDICATING THAT THE PARENT,
2 LEGAL GUARDIAN, OR PERSON IN LOCO PARENTIS HAS READ AND UNDER-
3 STOOD THE STATEMENT REQUIRED UNDER SECTION 13403(1), CONSENTS TO
4 THE MINOR'S USE OF A TANNING DEVICE, AND AGREES THAT THE MINOR
5 WILL USE EITHER HIS OR HER OWN PROTECTIVE EYEWEAR OR THE PROTEC-
6 TIVE EYEWEAR MADE AVAILABLE BY THE TANNING FACILITY.

7 (2) THE OWNER OR OPERATOR OF A TANNING FACILITY SHALL NOT
8 ALLOW A MINOR WHO IS LESS THAN 14 YEARS OF AGE TO USE A TANNING
9 DEVICE IN THE TANNING FACILITY UNLESS THE MINOR IS ACCOMPANIED TO
10 THE TANNING FACILITY BY A PARENT, LEGAL GUARDIAN, OR PERSON IN
11 LOCO PARENTIS AND THE PARENT, LEGAL GUARDIAN, OR PERSON IN LOCO
12 PARENTIS SIGNS A STATEMENT IN THE SAME MANNER AS REQUIRED UNDER
13 SUBSECTION (1).

14 (3) AN INDIVIDUAL WHO USES A TANNING DEVICE IN A TANNING
15 FACILITY SHALL USE EITHER HIS OR HER OWN PROTECTIVE EYEWEAR OR
16 THE PROTECTIVE EYEWEAR MADE AVAILABLE BY THE TANNING FACILITY,
17 PURSUANT TO SECTION 13405(D).

18 Section 2. This amendatory act shall not take effect unless

20 of the 88th Legislature is enacted into law.
