

SENATE BILL No. 1028

May 14, 1996, Introduced by Senator ROGERS and referred to the Committee on Judiciary.

A bill to amend Act No. 280 of the Public Acts of 1939, entitled as amended

"The social welfare act,"

as amended, being sections 400.1 to 400.119b of the Michigan Compiled Laws, by adding section 115n.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 280 of the Public Acts of 1939, as
- 2 amended, being sections 400.1 to 400.119b of the Michigan
- 3 Compiled Laws, is amended by adding section 115n to read as
- 4 follows:
- 5 SEC. 115N. (1) IF A JUVENILE ESCAPES FROM A FACILITY OR
- 6 RESIDENCE FUNDED OR AUTHORIZED UNDER THIS ACT IN WHICH HE OR SHE
- 7 HAS BEEN PLACED, THE INDIVIDUAL HAVING RESPONSIBILITY FOR
- 8 MAINTAINING CUSTODY OF THE JUVENILE AT THE TIME OF THE ESCAPE
- 9 SHALL IMMEDIATELY NOTIFY ALL OF THE FOLLOWING OF THE ESCAPE OR

- 1 CAUSE ALL OF THE FOLLOWING TO BE IMMEDIATELY NOTIFIED OF THE
- 2 ESCAPE:
- 3 (A) IF THE ESCAPE OCCURS IN A CITY, VILLAGE, OR TOWNSHIP,
- 4 THE POLICE DEPARTMENT OF THAT CITY, VILLAGE, OR TOWNSHIP.
- 5 (B) THE SHERIFF DEPARTMENT OF THE COUNTY IN WHICH THE ESCAPE
- 6 OCCURS.
- 7 (C) THE DEPARTMENT OF STATE POLICE POST HAVING JURISDICTION
- 8 OVER THE AREA IN WHICH THE ESCAPE OCCURS.
- 9 (2) AS USED IN THIS SECTION:
- 10 (A) "ESCAPE" MEANS TO LEAVE WITHOUT LAWFUL AUTHORITY OR TO
- 11 FAIL TO RETURN TO CUSTODY WHEN REQUIRED.
- 12 (B) "JUVENILE" MEANS 1 OR MORE OF THE FOLLOWING:
- 13 (i) AN INDIVIDUAL UNDER THE JURISDICTION OF THE PROBATE
- 14 COURT UNDER SECTION 2(A)(1) OF CHAPTER XIIA OF ACT NO. 288 OF THE
- 15 PUBLIC ACTS OF 1939, BEING SECTION 712A.2 OF THE MICHIGAN
- 16 COMPILED LAWS.
- 17 (ii) AN INDIVIDUAL UNDER THE JURISDICTION OF THE CIRCUIT
- 18 COURT UNDER SECTION 606 OF THE REVISED JUDICATURE ACT OF 1961,
- 19 ACT NO. 236 OF THE PUBLIC ACTS OF 1961, BEING SECTION 600.606 OF
- 20 THE MICHIGAN COMPILED LAWS.
- 21 (iii) AN INDIVIDUAL UNDER THE JURISDICTION OF THE RECORDER'S
- 22 COURT OF THE CITY OF DETROIT UNDER SECTION 10A(1)(C) OF ACT
- 23 NO. 369 OF THE PUBLIC ACTS OF 1919, BEING SECTION 725.10A OF THE
- 24 MICHIGAN COMPILED LAWS.
- 25 Section 2. This amendatory act shall not take effect unless
- 26 all of the following bills of the 88th Legislature are enacted
- 27 into law:
