SENATE BILL NO. 758

(As Passed the Senate December 3, 1997)

A bill to amend 1976 PA 451, entitled "The revised school code," (MCL 380.1 to 380.1852) by adding sections 1606b, 1606c, 1606d, and 1606e.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1606B. (1) THE BOARD OF A SCHOOL DISTRICT OPERATING A
- 2 COMMUNITY COLLEGE UNDER THIS PART MAY ESTABLISH A DEPARTMENT OF
- 3 PUBLIC SAFETY FOR THAT COMMUNITY COLLEGE FOR THE PROTECTION OF
- 4 PERSONS AND PROPERTY.
- 5 (2) IF THE BOARD OF THE SCHOOL DISTRICT ESTABLISHES A
- 6 DEPARTMENT OF PUBLIC SAFETY UNDER SUBSECTION (1), THE BOARD MAY
- 7 GRANT TO THE PUBLIC SAFETY OFFICERS THE AUTHORITY OF PEACE OR LAW
- 8 ENFORCEMENT OFFICERS.

- 8 THE STAFF OF THE COMMUNITY COLLEGE. THE PUBLIC SAFETY ADVISORY
- 9 COMMITTEE SHALL RECEIVE AND ADDRESS GRIEVANCES BY PERSONS AGAINST
- 10 THE PUBLIC SAFETY OFFICERS OR AGAINST THE PUBLIC SAFETY DEPART-
- 11 MENT OF THAT COMMUNITY COLLEGE. THE COMMITTEE MAY RECOMMEND TO
- 12 THE BOARD OR THE ADMINISTRATION OF THAT COMMUNITY COLLEGE THAT
- 13 DISCIPLINARY MEASURES BE TAKEN AGAINST A PUBLIC SAFETY OFFICER OR
- 14 POLICE OFFICER WHO IS FOUND RESPONSIBLE FOR MISCONDUCT IN
- 15 OFFICE.
- 16 SEC. 1606C. (1) THE JURISDICTION OF PUBLIC SAFETY OFFICERS
- 17 OR POLICE OFFICERS GRANTED POWERS AND AUTHORITY UNDER SECTION
- 18 1606B SHALL INCLUDE ALL PROPERTY OWNED OR LEASED BY THE COMMUNITY
- 19 COLLEGE IN THIS STATE AND EXTENDS TO THE PUBLIC RIGHT-OF-WAY
- 20 TRAVERSING OR CONTIGUOUS TO THAT PROPERTY.
- 21 (2) THE JURISDICTION OF PUBLIC SAFETY OFFICERS OR POLICE
- 22 OFFICERS UNDER SUBSECTION (1) IS LIMITED TO THE PROTECTION OF
- 23 PERSONS AND PROPERTY ON THE PROPERTY OF THAT COMMUNITY COLLEGE
- 24 UNLESS A RESPONSE IS MADE OFF CAMPUS AT THE SPECIFIC REQUEST OF
- 25 ANOTHER LAW ENFORCEMENT AGENCY OR UNDER A MUTUAL AID AGREEMENT
- 26 WITH ANOTHER LAW ENFORCEMENT AGENCY.
