- 22 (D) ACCEPT GIFTS, GRANTS, OR BEQUESTS FROM ANY PUBLIC OR

- 2 WITHIN THE STATE TREASURY.
- 3 (2) THE FUND MAY RECEIVE MONEY AS PROVIDED IN THIS PART AND
- 4 FROM ANY OTHER SOURCE. THE STATE TREASURER SHALL DIRECT THE
- 5 INVESTMENT OF THE FUND. THE STATE TREASURER SHALL CREDIT TO THE
