SB 731 as amended October 22, 1997 4 (b) "Instrumentality of a crime" means any property, other 2 than real property, the use of which contributes directly and 3 materially to the commission of a crime. (c) "Person" means an individual, corporation, partnership, 5 or other business entity, or an unincorporated or voluntary 6 association. 7 (d) "Proceeds of a crime" means any property obtained 8 through the commission of a crime, including any appreciation in 9 the value of the property. 10 (e) "Security interest" means any interest in real or per-11 sonal property that secures payment or performance of an 12 obligation.
