## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 503B. (1) NOTWITHSTANDING ANY OTHER PROVISION OF THIS
- 2 ACT, IF THE COMMISSION DETERMINES, AND THE LEGISLATURE DEMON-
- 3 STRATES ITS CONCURRENCE IN THAT DETERMINATION BY CONCURRENT RESO-
- 4 LUTION AND RECORD ROLL CALL OF A MAJORITY OF THE MEMBERS ELECTED
- 5 AND SERVING IN EACH HOUSE OF THE LEGISLATURE, STATE OWNED PROP-
- 6 ERTY DESCRIBED IN THIS SECTION MAY BE DESIGNATED AS RESERVED
- 7 PROPERTY UPON WHICH SUBSURFACE MINERAL OR OTHER INTERESTS SHALL
- 8 NOT BE DEVELOPED OR EXPLOITED, AND SHALL BE RETAINED BY THE STATE
- 9 FOR A PERIOD OF 10 YEARS, UNLESS EXTENDED AS PROVIDED UNDER
- 10 SUBSECTION (2). PROPERTY ELIGIBLE FOR THE DESIGNATION PROVIDED

- 17 ERNMENT TO WHICH THE PROPERTY WILL BE TRANSFERRED OF THE LIMITA-
