THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1531D. (1) BEGINNING JULY 1, 1997, THE STATE BOARD
- 2 SHALL NOT ISSUE AN INITIAL TEACHING CERTIFICATE TO A PERSON
- 3 UNLESS THE PERSON PRESENTS EVIDENCE SATISFACTORY TO THE STATE
- 4 BOARD THAT THE PERSON HOLDS VALID CERTIFICATION IN FIRST AID AND
- 5 IN CARDIOPULMONARY RESUSCITATION APPROVED BY THE DEPARTMENT AND
- 6 ISSUED BY THE AMERICAN RED CROSS OR A COMPARABLE ORGANIZATION OR
- 7 INSTITUTION APPROVED BY THE DEPARTMENT, OR PROVIDES EVIDENCE SAT-
- 8 ISFACTORY TO THE STATE BOARD THAT THE PERSON HAS PHYSICAL LIMITA-
- 9 TIONS THAT MAKE IT IMPRACTICABLE FOR THE PERSON TO OBTAIN THE
- 10 REQUIRED CERTIFICATION.

- 1 (2) THE STATE BOARD SHALL REQUIRE EACH PERSON INITIALLY
