- 3 NETWORK SYSTEM. THE SENTINEL NETWORK SYSTEM SHALL PROVIDE COUN-
- 4 SELING AND OTHER SUPPORT SERVICES REGARDING NEONATAL ADDICTION
- 5 AND FETAL ALCOHOL SYNDROME.
- 6 (2) A HEALTH CARE PROVIDER EMPLOYED BY OR UNDER CONTRACT TO
- 7 THE DEPARTMENT SHALL MAKE A HOME VISIT AND ATTEMPT TO PROVIDE
- 8 SUPPORT SERVICES WITHIN 14 DAYS AFTER THE DEPARTMENT RECEIVES A
