THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

SEC. 3406F. (1) EFFECTIVE JANUARY 1, 1998, AN INSURER THAT
DELIVERS, ISSUES FOR DELIVERY, OR RENEWS IN THIS STATE AN
EXPENSE-INCURRED HOSPITAL, SURGICAL, OR MEDICAL POLICY OR CERTIF ICATE THAT OFFERS DEPENDENT COVERAGE SHALL PROVIDE OR OFFER TO
PROVIDE THAT THE DEPENDENT COVERAGE APPLICABLE TO CHILDREN
INCLUDE COVERAGE FOR VACCINES TO IMMUNIZE AGAINST THE DISEASES
AND INFECTIONS LISTED IN SUBSECTION (2) AND SHALL PROVIDE OR
OFFER TO PROVIDE FOR COVERAGE FOR THE ADMINISTRATION OF THE VAC CINES FROM THE MOMENT OF BIRTH OR PLACEMENT FOR ADOPTION THROUGH
THE AGE OF 36 MONTHS.

17 (4) THIS SECTION DOES NOT APPLY TO LIMITED CLASSIFICATION **18** POLICIES.

(5) AS USED IN THIS SECTION, "LIMITED CLASSIFICATION 19 20 POLICIES" MEANS AN ACCIDENT ONLY POLICY OR CERTIFICATE, A LIMITED 21 ACCIDENT POLICY OR CERTIFICATE, OR A SPECIFIED DISEASE POLICY OR **22** CERTIFICATE.
