## **HOUSE BILL No. 4396**

February 27, 1997, Introduced by Reps. Mathieu, Griffin, McManus, Prusi, Anthony, Harder, Brackenridge, Kaza, Walberg, Wetters and Baade and referred to the Committee on Commerce.

A bill to amend 1933 (Ex Sess) PA 8, entitled "The Michigan liquor control act," by amending section 28c (MCL 436.28c), as amended by 1992 PA 133.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 28c. (1) The commission shall not prohibit an appli-
- 2 cant for or the holder of a specially designated distributor
- 3 license or specially designated merchant license from owning or
- 4 operating motor vehicle fuel pumps on or adjacent to the licensed
- 5 premises, if both of the following conditions are met:
- 6 (a) —One— EITHER or both of the following: —conditions
- 7 exist:
- **8** (*i*) The applicant or licensee is located in a neighborhood
- 9 shopping center composed of 1 or more commercial establishments
- 10 organized or operated as a unit which is related in location,

- 1 size, and type of shop to the trade area that the unit serves,
- 2 which provides not less than 50,000 square feet of gross leasable
- 3 retail space, and which provides 5 private off-street parking
- 4 spaces for each 1,000 square feet of gross leasable retail
- 5 space.
- 6 (ii) The applicant or licensee maintains a minimum inventory
- 7 on the premises, excluding alcoholic liquor and motor vehicle
- 8 fuel, of not less than \$250,000.00, at cost, of those goods and
- 9 services customarily marketed by approved types of businesses.
- 10 (b) The site of payment and selection of alcoholic liquor is
- 11 not less than 50 feet from that point where motor vehicle fuel is
- 12 dispensed.
- 13 (2) The commission shall not prohibit an applicant for or
- 14 the holder of a specially designated merchant license from owning
- 15 or operating motor vehicle fuel pumps on or adjacent to the
- 16 licensed premises if -both EITHER of the following conditions
- 17 are met:
- 18 (a) The applicant or licensee is located in either of the

- 23 or more.
- 24 (ii) A city, incorporated village, or township with a popu-
- 25 lation of 3,500 or less and a county with a population of less
- 26 than 31,000.

- 1 (b) The applicant or licensee maintains a minimum inventory
- 2 on the premises, excluding alcoholic liquor and motor vehicle
- 3 fuel, of not less than \$10,000.00, at cost, of those goods and
- 4 services customarily marketed by approved types of businesses.
- 5 (3) The commission shall not prohibit an applicant for or
- 6 the holder of a specially designated distributor license from
- 7 owning or operating motor vehicle fuel pumps on or adjacent to
- 8 the licensed premises if both of the following conditions are
- **9** met:
- 10 (a) The applicant or licensee is located in either of the
- 11 following:
- 12 (i) A city, incorporated village, or township with a popula-
- 13 tion of 3,000 or less and a county with a population of 31,000 or
- 14 more.
- 15 (ii) A city, incorporated village, or township with a popu-
- 16 lation of 3,500 or less and a county with a population of less
- 17 than 31,000.
- (b) The applicant or licensee maintains a minimum inventory
- 19 on the premises, excluding alcoholic liquor and motor vehicle
- 20 fuel, of not less than \$12,500.00, at cost, of those goods and
- 21 services customarily marketed by approved types of businesses.
- 22 (4) A person who was issued a specially designated merchant
- 23 license or specially designated distributor license at a location
- 24 at which another person owned, operated or maintained motor vehi-
- 25 cle fuel pumps at the same location may have or acquire an inter-
- 26 est in the ownership, operation or maintenance of those motor
- 27 vehicle fuel pumps.

- 1 (5) The commission may transfer ownership of a specially
- 2 designated merchant license or specially designated distributor
- 3 license to a person who owns or is acquiring an interest in motor
- 4 vehicle fuel pumps already in operation at the same location at
- 5 which the license is issued.
