THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 128. (1) SUBJECT TO SUBSECTIONS (2) AND (3), THE BOARD
- 2 OF TRUSTEES OF A COMMUNITY COLLEGE CREATED UNDER THIS ACT MAY
- 3 GRANT TO THE PUBLIC SAFETY OFFICERS OR POLICE OFFICERS OF THAT
- 4 COMMUNITY COLLEGE THE POWERS AND AUTHORITY OF A PEACE OFFICER.
- 5 PUBLIC SAFETY OFFICERS OR POLICE OFFICERS GRANTED THE POWERS AND
- 6 AUTHORITY UNDER THIS ACT SHALL HAVE THE SAME POWERS AND AUTHORITY
- 7 OF A PEACE OFFICER UNDER THE CODE OF CRIMINAL PROCEDURE, 1927

- 1 (2) BEFORE GRANTING THE POWERS AND AUTHORITY PROVIDED UNDER
- 2 SUBSECTION (1), A BOARD OF TRUSTEES OF A COMMUNITY COLLEGE SHALL
