A bill to amend 1976 PA 388, entitled "Michigan campaign finance act," (MCL 169.201 to 169.282) by adding section 40.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 40. (1) A COMMITTEE THAT HOLDS OR SPONSORS A FUND
- 2 RAISING EVENT OR IS PRESENT AT ANY OTHER EVENT AT WHICH EVENT
- 3 POLITICAL MERCHANDISE IS SOLD TO BENEFIT THE COMMITTEE IS SUBJECT
- 4 TO THIS SECTION. THE PROVISIONS OF THIS SECTION ARE IN ADDITION
- 5 TO ALL OTHER PROVISIONS OF THIS ACT APPLICABLE TO THE COMMITTEE,
- 6 TO THE FUND RAISING EVENT OR OTHER EVENT, AND TO THE SALE OF
- 7 POLITICAL MERCHANDISE.
- 8 (2) BEFORE POLITICAL MERCHANDISE IS SOLD AT THE EVENT, THE
- 9 COMMITTEE SHALL POST A SIGN OR SIGNS THAT MEET ALL OF THE
- 10 FOLLOWING REQUIREMENTS:

- 1 (A) ARE VISIBLE TO ANY PERSON APPROACHING THE SALE AREA,
- 2 BEFORE THAT INDIVIDUAL OFFERS TO PURCHASE THE POLITICAL

- 4 (B) ARE LARGE ENOUGH AND HAVE LARGE ENOUGH TYPEFACE TO BE
- 5 EASILY READ BY THE GENERAL PUBLIC FROM A DISTANCE OF 5 FEET OR
- 6 MORE FROM THE SALE AREA.
- 7 (C) CONTAIN ALL OF THE FOLLOWING:
- 8 (i) THE FOLLOWING STATEMENT: "A PORTION OF THE PROCEEDS
- 9 FROM THE MERCHANDISE SOLD AT THIS EVENT WILL BE USED FOR POLITI-
- 10 CAL PURPOSES.".
- 11 (ii) THE NAME OF THE COMMITTEE HOLDING, SPONSORING, OR
- 12 PRESENT AT THE EVENT.
- 13 (iii) THE NAME OF THE CANDIDATE OR BALLOT QUESTION, IF ANY,
- 14 SUPPORTED OR OPPOSED BY THE COMMITTEE DESCRIBED IN SUBPARAGRAPH
- **15** (*ii*).
- 16 (iv) THE PORTION OF THE PROCEEDS FROM THE SALE OF THE POLIT-
- 17 ICAL MERCHANDISE THAT WILL BE ALLOCATED TO THE COMMITTEE
- 18 DESCRIBED IN SUBPARAGRAPH (ii).
- 19 (v) A STATEMENT INDICATING THAT IT IS A VIOLATION OF
- 20 MICHIGAN LAW TO SPEND MORE THAN \$20.00 PURCHASING MERCHANDISE AT
- 21 THE EVENT, UNLESS THE NAME, ADDRESS, AND OCCUPATION, IF APPLICA-
- 22 BLE, OF THE PURCHASER IS RECORDED AS REQUIRED BY THIS ACT.
- 23 (3) THE COMMITTEE SHALL ENSURE THAT THE SIGN OR SIGNS POSTED

- 24 PURSUANT TO THIS SECTION REMAIN POSTED DURING THE ENTIRE TIME
- 25 THAT POLITICAL MERCHANDISE IS OFFERED FOR SALE AT THE EVENT.
