THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 PART 88 NONPOINT SOURCE POLLUTION PREVENTION AND CONTROL GRANTS
- 2 SEC. 8801. AS USED IN THIS PART:
- 3 (A) "DEPARTMENT" MEANS THE DEPARTMENT OF ENVIRONMENTAL
- 4 OUALITY.
- 5 (B) "DIRECTOR" MEANS THE DIRECTOR OF THE DEPARTMENT.
- 6 (C) "GRANT" MEANS A NONPOINT SOURCE POLLUTION PREVENTION AND
- 7 CONTROL GRANT UNDER THIS PART.
- 8 (D) "LOCAL UNIT OF GOVERNMENT" MEANS A COUNTY, CITY, VIL-
- 9 LAGE, OR TOWNSHIP, OR AN AGENCY OF A COUNTY, CITY, VILLAGE, OR
- 10 TOWNSHIP; THE OFFICE OF A COUNTY DRAIN COMMISSIONER; A SOIL
- 11 CONSERVATION DISTRICT ESTABLISHED UNDER PART 93; A WATERSHED

- 1 COUNCIL; A LOCAL HEALTH DEPARTMENT AS DEFINED IN SECTION 1105 OF
- 2 THE PUBLIC HEALTH CODE, 1978 PA 368, MCL 333.1105; AN AUTHORITY
- 3 OR ANY OTHER PUBLIC BODY CREATED BY OR PURSUANT TO STATE LAW; OR

- 22 THE PHYSICAL IMPROVEMENT PORTION OF WATERSHED PLANS APPROVED BY
- 23 THE DEPARTMENT UNDER SECTION 8805.
- 24 (2) FOR ANY GRANT ISSUED UNDER THIS PART, THE DEPARTMENT
- 25 SHALL REQUIRE THAT A LOCAL UNIT OF GOVERNMENT CONTRIBUTE 30% OF
- 26 THE TOTAL PROJECT'S COST FROM OTHER PUBLIC OR PRIVATE FUNDING
- 27 SOURCES. THE DEPARTMENT MAY APPROVE IN-KIND SERVICES TO MEET ALL

- 1 OR A PORTION OF THE MATCH REQUIREMENT PROVIDED IN THIS
- 2 SUBSECTION. IN ADDITION, THE DEPARTMENT MAY WAIVE THE MATCH
- 3 REQUIREMENT REQUIRED IN THIS SUBSECTION IF THE GRANT APPLICANT
- 4 ENTERS INTO A CONTRACT THAT PROVIDES FOR MAINTENANCE OF THE
- 5 PROJECT OR PRACTICES THAT ARE FUNDED UNDER TERMS ACCEPTABLE TO
- 6 THE DEPARTMENT.
- 7 SEC. 8803. A LOCAL UNIT OF GOVERNMENT THAT WISHES TO APPLY
- 8 FOR A GRANT SHALL SUBMIT A GRANT APPLICATION TO THE DEPARTMENT IN
- 9 A MANNER PRESCRIBED BY THE DEPARTMENT AND CONTAINING THE INFORMA-
- 10 TION REQUIRED BY THE DEPARTMENT. THE GRANT APPLICATION SHALL
- 11 ALSO INCLUDE ALL OF THE FOLLOWING:
- 12 (A) A DETAILED DESCRIPTION OF THE PROJECT FOR WHICH THE
- 13 GRANT IS SOUGHT.
- 14 (B) A DISCUSSION OF HOW THE PROJECT IS CONSISTENT WITH AN
- 15 APPROVED WATERSHED PLAN, IF APPLICABLE.
- 16 (C) A DESCRIPTION OF THE TOTAL COST OF THE PROJECT AND THE
- 17 SOURCE OF THE LOCAL GOVERNMENT'S CONTRIBUTION TO THE PROJECT.
- 18 SEC. 8804. UPON RECEIPT OF A GRANT APPLICATION PURSUANT TO
- 19 SECTION 8803, THE DIRECTOR SHALL CONSIDER THE PROJECTS PROPOSED
- 20 TO BE FUNDED AND THE EXTENT THAT MONEY IS AVAILABLE FOR GRANTS
- 21 UNDER THIS PART, AND SHALL ISSUE GRANTS FOR PROJECTS THAT THE
- 22 DIRECTOR DETERMINES WILL ASSIST IN THE PREVENTION OR CONTROL OF
- 23 POLLUTION FROM NONPOINT SOURCES.
- 24 SEC. 8805. (1) UPON REQUEST, THE DEPARTMENT SHALL REVIEW
- 25 AND APPROVE OR DISAPPROVE A WATERSHED PLAN THAT HAS BEEN SUBMIT-
- 26 TED TO THE DEPARTMENT.

- 1 (2) AN APPROVABLE WATERSHED PLAN SHALL ADDRESS ALL OF THE
- 2 FOLLOWING:
- 3 (A) THE BENEFICIAL USES AFFECTED BY NONPOINT SOURCE
- 4 POLLUTION.
- 5 (B) THE POLLUTANTS AFFECTING THE BENEFICIAL USES.
- 6 (C) THE SOURCES OF THE POLLUTANTS.
- 7 (D) THE SELECTED METHODS OF CONTROLLING THE POLLUTANTS,
- 8 INCLUDING PHYSICAL IMPROVEMENTS, INSTITUTIONAL CHANGES, AND AN
- 9 INFORMATION OR EDUCATION CAMPAIGN.
- 10 (3) THE DEPARTMENT SHALL GIVE PUBLIC NOTICE OF ITS INTENT TO
- 11 APPROVE A WATERSHED PLAN AND SHALL CONSIDER COMMENTS ON THAT
- 12 INTENT FOR A 30-DAY PERIOD. IF 2 OR MORE LOCAL UNITS OF GOVERN-
- 13 MENT SUBMIT WATERSHED PLANS FOR THE SAME WATERSHED, THE DEPART-
- 14 MENT SHALL RETURN THE PLANS WITH THE DIRECTION TO THE LOCAL UNITS
- 15 OF GOVERNMENT TO WORK TOGETHER TO DEVELOP A SINGLE WATERSHED PLAN
- 16 SUBMITTED BY 1 LOCAL UNIT OF GOVERNMENT.
- 17 SEC. 8806. THE DEPARTMENT MAY PROMULGATE RULES TO IMPLEMENT
- 18 THIS PART.
